RELEASE OF THE TOWNSHIP'S PHASED REOPENING PLAN

As announced on June 5, 2020, the Township has prepared a plan that addresses the reopening of parks, recreation activities, and timelines for other services as the Township enters the yellow and green phases established by the Governor. The plan, which can be viewed below, is categorized by main Township services in dark grey in the first column. Those services, where applicable, are further broken down into light grey, left-aligned sub-headings.

It is important to note that this document will be updated as recommendations and directives change and develop. Additionally, some items are dependent upon when the Township enters the green phase, such as the reopening of Township pools. The plan has been developed with the guidance put forth by the <u>U.S.</u> <u>Centers for Disease Control (CDC)</u>, <u>Pennsylvania Department of Health (PA DOH)</u>, <u>Governor's office</u>, and <u>Pennsylvania Recreation and Park Society (PRPS)</u>, among others. As the health, safety, and welfare of our residents, visitors, and employees is our top priority, the Township is committed to meeting federal, state, and county safety and cleanliness standards and will aggressively monitor and modify our plans, as needed.

As prescribed in the plan and consistent with the guidance of governing bodies, we are requesting the continued practice of social distancing measures that have proven effective, such as maintaining at least 6 feet distance from others and wearing face masks. This will ensure that we continue to progress into the next phases and ultimately return to normal. We look forward to the reopening of the Township and greatly appreciate your cooperation and continued understanding.
