PLEDGE OF ALLEGIANCE

PRESENTATION:

<u>Presentation of Commendation to Eagle Scout Austin Todd Groeber:</u>

Commissioner Gillespie presented Certificate of Commendation to Eagle Scout Austin Todd Groeber of Troop 48 on behalf of a proud community saluting Austin on obtaining the Eagle Scout rank of the Boy Scouts of America. In achieving this honor, he earned assorted merit badges, which attest to his leadership qualities and his contribution to our community. Austin's completed project resulted in leading a crew of scouts and parents in planting native trees and shrubs along previously polluted and overgrown waterway in Grove Park in Roslyn. The newly planted area will provide habitat for birds and small native animals and will keep invasive and noxious species from repopulating the area that will benefit the community for many years.

On behalf of the Board of Commissioners of the Township of Abington along with the Boy Scout Troop 48 and Austin's family and friends in extending their congratulations on this milestone on this 9th day of November, 2017.

PRESIDENT'S ANNOUNCEMENT:

President Luker announced that the Township is accepting letters of interest to serve on the various boards, commissions and committees of the Township for calendar year 2018. Anyone who has interest or questions should contact the office of the Township Manager.

APPROVAL OF MINUTES:

Vice President Kline made a MOTION, seconded by Commissioner Spiegelman to approve the minutes of the Board of Commissioners Meeting of October 12, 2017.

MOTION was ADOPTED 15-0.

PUBLIC COMMENT-AGENDA ITEMS ONLY:

Lora Lehmann, 1431 Bryant Lane, commented that she was opposed to waiving permit fees for the School District and Roslyn VFW. She was also opposed to the request for text amendment by Hightop Real Estate Group.

PUBLIC SAFETY COMMITTEE:

Chief Livingood explained that Items PS-01, PS-02 and PS-03 as listed on the agenda represent the next step in the Police Department's succession plan. The first two items are extremely important as they establish top leadership in the department's future.

Deputy Chief Pat Molloy is extremely well-qualified to be the next Chief of Police in Abington. He has served as his Deputy Chief for a number of years and is the Commanding Officer of the Patrol Division, which is the largest and most complex division in the department. Pat has a Bachelors and Master Degrees from St. Joseph's University and is a graduate of the FBI National Academy. He is skilled and highly capable police executive with excellent police personal communication skills. He is also an extremely passionate person and who is someone everyone turns to when they need special help. Pat is well-respected by the officers, staff and dedicated volunteers as well as members of the community. Deputy Chief Patrick Molloy is completely capable and qualified to be Abington's next Chief of Police.

Manager Manfredi added that it is fortunate, for the succession plan that this Board of Commissioners authorized and that this police department put forth, the selection of Pat Molloy as the next Chief of Police, which was a very good decision.

Affirm the Promotion of Deputy Chief Patrick Molloy as Chief of Police

Commissioner Schreiber made a MOTION, seconded by Commissioner Kalinoski to affirm the promotion of Deputy Chief Patrick Molloy as the Chief of Police effective February 1, 2018 or whenever current Chief John A. Livingood retires, whichever is sooner.

Commissioner Luker asked for any comments from Commissioners or staff. There were none.

MOTION was ADOPTED 15-0.

Chief Livingood said the Deputy Chief's position of Abington Township's Police Department is an appointed position, appointed by the Chief of Police. Tonight, we officially appoint Lieutenant Kelley Warner as our next Deputy Chief of Police. Kelley's appointment now will ease the transition when he retires and Patrick Molloy becomes Chief of Police in which he and Pat Molloy wholeheartedly agree on this appointment.

Kelley has both a Bachelors and Masters Degrees from West Chester University and is a graduate of Northwestern University School of Police Staff and Command as well as several other police management and leadership courses. Kelley Warner joined our department as a Patrol Officer in January 1989.

In 1996, she was appointed as Juvenile Detective and among other achievements helped Abington to create the first Youth Aid Panel. Kelley was promoted to Sergeant in 2000 and reassigned to the Patrol Division. She was promoted to Lieutenant in August 2013 and assumed command of a Patrol Platoon. In her spare time, she served as an Accreditation Manager overseeing the department's fourth Pennsylvania Law Enforcement Re-Accreditation Commission (PLEAC). Lieutenant Warner continued in her role as Accreditation Manager for the department's international re-accreditation from Commission on Accreditation Law Enforcement Agencies (CALEA) after she was transferred to and became Commanding Officer of the Community Policing Division.

Kelley has led the Community Division to new heights and has helped lead us into the social media stage of communicating with our community and our department. One of her major achievements was overseeing and developing the Abington HUD, which is a new innovative way to utilize private, County and local resources until police solve nontraditional police problems that have become a model for the entire region.

Newly promoted Chief Pat Molloy commented that Kelley Warner was the first and only female SWAT Officer in Abington Township's history paving the way for another female officer, who is competing for that position at this time. Back in 1996, former Chief Kelly came up with a new position called, "Juvenile Aid Detective" forming relationships with the School District paving the way for our current SRO (School Resource Officer) program. Kelley's position as President of the Mid-Atlantic Women in Law Enforcement shows her commitment to the profession especially women in this profession. Also, she is committed to the Unity Bike Tour to raise awareness of officers killed in the line of duty and to raise funds for Police Memorials.

Chief Livingood and newly promoted Chief Patrick Molloy affirmed and promoted Lieutenant Kelley Warner as Deputy Chief of Police of Abington Township Police Department before the Board of Commissioners of the Township of Abington on this 9th day of November, 2017.

Promotion of Officer Joseph Blei to the Rank of Sergeant

Commissioner Schreiber made a MOTION, seconded by Commissioner Kalinoski to appoint and approve the promotion of Officer Joseph Blei to Police Sergeant effective November 13, 2017.

Commissioner Luker asked for any comments from Commissioners or staff. There were none.

MOTION was ADOPTED 15-0.

Bids for Police Equipment and Uniforms

Commissioner Schreiber made a MOTION, seconded by Commissioner Kalinoski to award the contract for furnishing Police Equipment to American Uniform Sales, Inc. and to award the contract for furnishing Police Uniforms to Red the Uniform Tailor.

Commissioner Luker asked for any comments from Commissioners or staff. There were none.

MOTION was ADOPTED 15-0.

CODE ENFORCEMENT AND LAND DEVELOPMENT COMMITTEE:

Commissioner Sanchez noted that Items CE-01-110117 and CE-02-110117 refer to Item CE-05-110917 as listed on the agenda.

Request for Consideration of a Text Amendment by Hightop Real Estate Group

Commissioner Sanchez noted that this item was passed out of committee on a motion to advertise for a hearing; however, there are items still in need of review by the Township's Planning Commission and the MCPC.

Manager Manfredi added that the text amendment and other information needs to be vetted further, so the recommendation is to table any further action until it has been properly reviewed.

Commissioner Sanchez made a MOTION, seconded by Commissioner Brodsky to TABLE consideration of the request of the Board of Commissioners of the Township of Abington to hold a public hearing to discuss whether or not to consider a zoning text amendment filed by Hightop Real Estate & Development Group to amend Article X MS-H Main Street High Intensity/Density District to add Old York Road Revitalization Modifications for Apartment Building Use.

Commissioner Luker asked for any other comments from Commissioners or staff.

Commissioner Hecker commented that the Board still does not have the information on the other properties that would be impacted by the mechanism being proposed by the developer. Since this will impact more than just his ward, it is prudent to have this information, so if the Board chooses to move forward, it will be done with the full consideration of potential impact of properties in the respective wards. He is in favor of this matter receiving a fair review, but in order for that to be done, further information needs to be reviewed in which we do not have yet, so he is in support of the approach being recommended this evening.

MOTION was ADOPTED 15-0.

Ordinance No. 2147 Zoning Text Amendment by Philadelphia Presbytery Homes

Commissioner Sanchez made a MOTION, seconded by Commissioner Kalinoski to schedule and to advertise a formal hearing of the Board of Commissioners of the Township of Abington on Thursday, December 14, 2017 for the zoning text amendment known as Proposed Ordinance No. 2147 filed Philadelphia Presbytery Homes for the proposed development of the Rydal Waters Property, amending the Zoning Ordinance of the Township of Abington, Relating to Provisions of the SNR Senior Neighborhood Residential, Riparian Corridor, Steep Slope and Open Space Districts.

Commissioner Luker asked for any comments from Commissioners or staff. There were none.

MOTION was ADOPTED 15-0.

Roslyn VFW/Abington School District Fee Waiver Requests and the Establishment of a Policy on Fees and Waiver of Fees

Commissioner Sanchez made a MOTION, seconded by Commissioner Kline to consider establishing criteria for fee waiver requests and to allow the Roslyn VW to proceed with and receive their building permit, conditioned upon their understanding the request for fee waiver will be decided at a later date, and they may have to pay all fees, and further, that the Abington School District may proceed with their professional review while the Land Development process continues with the fee waiver request being considered at a later date.

Commissioner Luker asked for any comments from Commissioners or staff.

Commissioner Myers asked has the Roslyn VFW been advised of this.

Mark Penecale, Planning & Zoning Officer, replied yes. The permit is conditioned that the fee is under consideration for a waiver.

Commissioner Myers clarified that criteria established will not just be for the Roslyn VFW; it will be for other nonprofits. Is that correct?

Manager Manfredi replied yes, for all nonprofits.

Commissioner Farren said regarding established criteria for waiver requests; is it strictly for institutional fee waiver requests or will it be a broad policy where residents can make application for waiver of fees.

Manager Manfredi replied it is for entities and organizations; not individuals; however, that is not to say that if someone wanted to make that request, they could. Criteria is being established so that the Board can limit as much as possible any arbitrary decisions as to what fees should be waived

Commissioner Myers said due to Commissioner Kalinoski's association with the VFW and her husband's association with the VFW; should we recuse ourselves from voting on this item as we do not want any kind of conflict of interest.

Solicitor Clarke replied this vote will not result in any direct financial benefit to either Commissioner Myers or Commissioner Kalinoski; therefore there is no need to abstain on this vote.

Commissioner Kalinoski clarified that he is manager of the North Penn VFW, and the concern of the manager of the Roslyn VFW is what happens when their project is completed and they cannot afford the fees because at some point fees will need to be charged.

Manager Manfredi replied normally for something of this nature, the applicant will proceed at their own risk, but he does not see criteria being established that would prohibit the Board from granting this waiver.

Commissioner Hecker commented that he is disinclined to be supportive of the waiver of fees, but the process proposed for criteria for our review makes sense.

Commissioner Bowman commented that we will decide the overall program for all nonprofits, and if the Roslyn VFW fits that criteria, then they will get the waiver as all others would in the future. Is that correct?

Manager Manfredi replied that is correct.

Commissioner Schreiber was excused from the meeting at 8:18 p.m. due to an emergency.

PUBLIC WORKS COMMITTEE:

Grit Collection System for W.W.T.P. – Contract #150

Commissioner Hecker made a MOTION, seconded by Commissioner Farren to approve the final payment for Contract No. 150, Grit Collection System for WWTP, to Derstine Company, LLC in the amount of \$23,350.00.

Commissioner Luker asked for any comments from Commissioners or staff. There were none.

MOTION was ADOPTED 14-0.

Final Payment for 1000 Block Edge Hill Road Curb and Sidewalk Project

Commissioner Hecker made a MOTION, seconded by Commissioner Spiegelman to final payment to Associated Paving Contractors, Inc. (APCON) in the amount of \$3,741.51 for the 2016/2017 HUD Program 1000 Block Edge Hill Road Curb and Sidewalk Project. A one-year maintenance bond was received.

Commissioner Luker asked for any comments from Commissioners or staff. There were none.

MOTION was ADOPTED 14-0.

Commissioner Hecker made a MOTION, seconded by Commissioner Farren to approve final payment to Almeida & Hudak Contractors, LLC in the amount of \$0 for the 2014 Capital Improvement Program-Phase II. A one-year maintenance bond was received.

Commissioner Luker asked for any comments from Commissioners or staff.

Commissioner Hecker asked for the reason why a motion needs to be made for no payment.

Commissioner Kline replied it is to close the contract out.

Old Welsh Road Sanitary Sewer Project Final Payment of \$4,800.00 to N. Abbonizzio Contractors

Commissioner Hecker made a MOTION, seconded by Commissioner Farren to approve final payment to N. Abbonizzio Contractors in the amount of \$4,800.00 for Contract No. 149 Sanitary Sewer Project. A one-year maintenance bond was received.

Commissioner Luker asked for any comments from Commissioners or staff. There were none.

MOTION was ADOPTED 14-0.

PUBLIC AFFAIRS COMMITTEE:

Disposition/Destruction of Abington Township Police Department Records

Commissioner Spiegelman made a MOTION, seconded by Commissioner Kalinoski to authorize the disposal/destruction of Accident, Utility, Offense reports, copies of traffic citations and completed/closed summary arrest reports from 2004 through 2010. Completed/Closed case folders, excluding major crime cases, through 1995. Police employee overtime cards, detail invoices, K9 sheets, payroll/deposit forms through 2011.

Commissioner Luker asked for any comments from Commissioners or staff. There were none.

<u>Authorization to Execute the Cooperation Agreement between Abington Township and the Redevelopment Authority of the County of Montgomery</u>

Commissioner Spiegelman made a MOTION, seconded by Commissioner Kalinoski to adopt Resolution No. 17-029 of the Township of Abington, County of Montgomery, Commonwealth of Pennsylvania, authorizing the President of the Board of Commissioners and the Township Secretary to execute a Cooperation Agreement with the Redevelopment Authority of the County of Montgomery.

Commissioner Luker asked for any comments from Commissioners or staff.

Commissioner Sanchez disclosed that he is on the Board of Jefferson Hospital and he does not receive any direct pecuniary benefit as result of it or anything at all from the hospital.

Commissioner Spiegelman noted that this cooperation agreement relates to a RACP grant for the hospital.

WHEREAS, the Board of Commissioners is now required to enter into a Cooperation Agreement with the Authority to memorialize the Township's guarantee of repayment of the Grant Funds.

COOPERATION AGREEMENT BETWEEN ABINGTON TOWNSHIP

AND

THE REDEVELOPMENT AUTHORITY OF THE COUNTY OF MONTGOMERY

THIS COOPERATION AGREEMENT, made the day of _______, 2017, between Abington Township (hereinafter the "Township") and the REDEVELOPMENT AUTHORITY OF THE COUNTY OF MONTGOMERY (hereinafter the "Authority".)

WHEREAS, the Authority is an independent agency created by the County of Montgomery (the "County") existing to carry out the public purposes of the Pennsylvania Urban Redevelopment Law, Act of Assembly of May 24, 1945, P.L. 991, 35 P.S. Section 1701 *et seq.*, as amended, and the Authority was established for the purpose, among other things, of encouraging the provisions of economic revitalization and decent living environments for persons of the Commonwealth of Pennsylvania (the "Commonwealth"); and

WHEREAS, the Township is a municipal corporation located in Montgomery County and has agreed to serve as the host municipality for the Enhancing the Patient Experience at Abington Memorial Hospital Project; and

WHEREAS, Abington Memorial Hospital (the "Developer") is located at 1200 York Road, Abington, Pennsylvania; and

WHEREAS, the Enhancing the Patient Experience at Abington Memorial Hospital Project (the "Project") is located at 1200 York Road, Abington Township (the "Property"); and

WHEREAS, in furtherance of its purpose, the Authority has, together with the Developer, submitted an application (the "Application", Exhibit A hereto) to the Commonwealth's Office of the Budget to receive a one million dollar grant (the "Grant Funds") through the Commonwealth's Redevelopment Assistance Capital Program (the "Program") to fund the renovations of the Abington Hospital Enhancing the Patient Experience Project (as more fully defined in the Application); and

WHEREAS, the Authority has entered into a contract (the "Contract", Exhibit B hereto) with the Commonwealth setting forth the terms, requirements and obligations and conditions in connection with the use of any Grant Funds awarded to the Authority by the Commonwealth under the Program; and

WHEREAS, pursuant to the terms and conditions of a Sub-grant Agreement dated, August 16, 2017 entered into by and between the Authority and the Developer, the Developer has agreed to comply with the terms of the Sub-grant Agreement attached hereto as Exhibit C; and

WHEREAS, in accordance with the Program requirements, the host municipality for the project must act as guarantor of certain contingent repayment obligations of the Authority under the Contract pursuant to the terms and conditions of this Agreement, and the Township is willing to do so in recognition of the benefits that inure to the Township and its residents as a result of the Project.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto, intending to be legally bound, agree as follows:

- 1. The Authority shall administer the Grant Funds in accordance with the terms and conditions set forth in the Contract and ensure that the Township shall receive a copy of each request for reimbursement for paid, eligible Project expenses submitted to the Commonwealth.
- 2. The Township agrees to absolutely, unconditionally and irrevocably guarantee to the Commonwealth, subject to any time period set forth in the Contract as applicable to the Authority and further subject to any rights and defenses applicable to the obligations of the Authority, the prompt and full repayment of all Grant Funds released by the Commonwealth to the Authority which the Authority is obligated to reimburse to the Commonwealth pursuant to the terms and conditions of the Contract ("Guaranty of Obligations").
- 3. The Township agrees to take all actions necessary in connection with the Guaranty of Obligations set forth in Paragraph 2 above, including the adoption of a Resolution by the Board of Commissioners of the Township authorizing the execution of this Agreement.
- 4. This Agreement shall commence upon full execution by the parties hereto and shall terminate upon the earlier to occur of (a) disbursement of all Grant Funds and the issuance by the Commonwealth of the close out certificate, and (b) termination of the Contract pursuant to the terms and conditions thereof, and full repayment to the Commonwealth of all Grant Funds released by the Commonwealth to the Authority which the Authority is obligated to reimburse to the Commonwealth pursuant to the terms and conditions of the Contract (the "Termination Date").
- 5. Upon the Termination Date, the parties hereto shall have no further liabilities, obligations or responsibilities to each other under this Agreement.
- 6. There shall be no additional amendments to this Agreement without the written consent of the parties.
- 7. This Agreement shall be binding upon the parties hereto, their heirs, successors, administrators and assigns and shall not be assigned to another party without written consent of each party hereto.
- 8. This Agreement shall be construed and interpreted under the laws of the Commonwealth of Pennsylvania.

WHEREAS, the Township of Abington, Montgomery County, Pennsylvania, is a township of the first class, organized and operating in accordance with the laws of the Commonwealth of Pennsylvania (the "Township"); and

WHEREAS, the Township, in the exercise of its lawful powers, intends to make certain roadway and other public improvements at or near State Route 2034 (Edge Hill Road), Section MG1, and/or State Route 2036 (Tyson Avenue), Section MG1, for the Edge Hill Road and Tyson Avenue Reconstruction Project, Federal Project Number X064193-L240, Pennsylvania Department of Transportation Project MSMP 57865 (the "Project"); and

WHEREAS, it is necessary for the Township to obtain permanent rights-of-way, permanent drainage easements, other permanent easements and temporary construction easements (collectively, "Rights-of-Way") from, across, and under certain real property not owned by the Township which is located along or near State Route 2034 (Edge Hill Road), Section MG1, and/or State Route 2036 (Tyson Avenue), Section MG1, for the construction of the intended roadway and other public improvements for the Project; and

WHEREAS, the Township has successfully obtained many of the Rights-of-Way for the Project through the negotiation process and by agreement with property owners; and

WHEREAS, the Township, in order to avoid exercising the power of eminent domain, has attempted to negotiate the acquisition of certain temporary construction easements from the following individual property owners (the "Property Owners") with property located in Abington Township, Montgomery County, Pennsylvania: Edward J. McCauley (Tax Map Parcel No. 30-00-16336-00-5); Harry M. Clegg, Widower (Tax Map Parcel No. 30-00-15432-00-9); Ivan F. Avila-Garcia and Loyda M. Garcia-Cordero (Tax Map Parcel No. 30-00-68796-00-6); John L. Anderson (Tax Map Parcel No. 30-00-69356-00-4); Robert A. White (Tax Map Parcel No. 30-00-68540-00-1); and Timothy McCauley and Gwen Murphy McCauley (Tax Map Parcel No. 30-00-16340-00-1) (collectively, the "Real Property"); and

WHEREAS, the Property Owners have been non-responsive to the negotiation process with the Township and, as a result, the Township cannot acquire the temporary construction easements by agreement from the Property Owners; and

WHEREAS, it is necessary for the Township to condemn the Real property, which is not owned by the Township, to complete the construction of the roadway and other public improvements for the Project; and

WHEREAS, the Township is authorized by law to exercise the power of eminent domain; and

WHEREAS, in furtherance of the Township's commitment to complete the construction of the roadway and other public improvements for the Project, the Township hereby condemns the Real Property for the aforesaid purposes.

NOW, THEREFORE, BE IT RESOLVED that, the Township hereby SELECTS, APPROPRIATES AND CONDEMNS certain temporary construction easements through, across and over the Real Property not owned by the Township, as set forth below:

- Temporary construction easement consisting of 729 square feet, more or less, from property owned by Edward J. McCauley, and identified as Montgomery County Tax Map Parcel No. 30-00-16336-00-5, as shown on Exhibit "A" attached hereto and incorporated herein by reference;
- Temporary construction easement consisting of 748 square feet, more or less, from property owned by Harry M. Clegg, Widower, and identified as Montgomery County Tax Map Parcel No. 30-00-15432-00-9, as shown on Exhibit "B" attached hereto and incorporated herein by reference;
- 3. Temporary construction easement consisting of 1,300 square feet, more or less, from property owned by Ivan F. Avila-Garcia and Loyda M. Garcia-Cordero, and identified as Montgomery County Tax Map Parcel No. 30-00-68796-00-6, as shown on Exhibit "C" attached hereto and incorporated herein by reference;
- 4. Temporary construction easement consisting of 185 square feet, more or less, from property owned by John L. Anderson, and identified as Montgomery County Tax Map Parcel No. 30-00-69356-00-4, as shown on Exhibit "D" attached hereto and incorporated herein by reference;
- 5. Temporary construction easement consisting of 87 square feet, more or less, from property owned by Robert A. White, and identified as Montgomery County Tax Map Parcel No. 30-00-68540-00-1, as shown on Exhibit "E" attached hereto and incorporated herein by reference; and
- 6. Temporary construction easement consisting of 350 square feet, more or less, from property owned by Timothy J. McCauley and Gwen Murphy McCauley, and

identified as Montgomery County Tax Map Parcel No. 30-00-16340-00-1, as shown on Exhibit "F" attached hereto and incorporated herein by reference.

Legal descriptions of and copies of the plans for the temporary construction easements required by the Township across each of the affected properties are available for inspection at the Township's offices.

FURTHER RESOLVED, that the proper officers of the Township, along with the Solicitor of the Township, are authorized and directed to take all steps necessary to carry out the purposes of this Resolution including, but not limited to, the completion and mailing of Pennsylvania Department of Transportation Forms LPS-34 (Notice of Condemnation to Claimant) and LPS-35 (Memorandum of Law-Your Rights as a Condemnee Under the Eminent Domain Code) to the Property Owners; the completion, mailing, filing or other disposition of any other requirements of the Pennsylvania Department of Transportation Forms; the satisfaction of any other requirements of the Pennsylvania Department of Transportation for the Project, and the satisfaction of the requirements of the Pennsylvania Eminent Domain Code, 26 Pa.C.S.A. § 101, et seq.; and

FURTHER RESOLVED, that all costs of these proceedings and the damages to be paid to the condemnees shall be paid from the revenues of the Township; and

FURTHER RESOLVED, this Resolution shall be effective immediately upon its adoption.

Commissioner Brodsky thanked and congratulated those from the police department who received promotions and who serve our community. He also thanked the Veterans for their service as well as to those who currently serve and honor our country.

President Luker thanked Mr. Curtis for his acknowledgment that Veteran's Day is this coming Saturday. He thanked Commissioner Kalinoski and to all of the Commissioners who are hosting events in honor of the Veterans and he applauded their commitment and dedication to Veterans.

Also, he gave credit and congratulated the Township's Finance Department, Finance Director Kevin Barron and Assistant Finance Director Jeannette Hermann and staff as they received once again Certificate of Achievement for Excellence in Financial Reporting from the Government Finance Officers Association presented to the Township of Abington, Pennsylvania for its comprehensive annual financial report of fiscal year ending December 31, 2016.

Finance Director Kevin Barron said this is the 14th consecutive year that the Finance Department received the CAFR award. The financial statements and 10-year history shows the entire picture of the Township's finances and economic sites.

President Luker said that is quite an accomplishment and thanked Mr. Barron and his staff on behalf of the Board of Commissioners of the Township of Abington.
