Commissioner Luker asked for any comments from Commissioners or staff.

Commissioner Myers noted that this particular grant is in no way attached to or associated with the Red Light Camera System program. It is a completely separate grant and funding.

Commissioner Luker asked for any comments from Commissioners or staff. There were none.

MOTION was ADOPTED 14-0.

CODE ENFORCEMENT AND LAND DEVELOPMENT COMMITTEE:

Consider Request for Consideration of Text Amendment by Hightop Real Estate Group:

Commissioner Kline said that any consideration by the Board tonight is to decide whether or not to advertise a public hearing on a subsequent date to consider proposed text amendment to the Zoning Ordinance.

Solicitor Clarke added that the Board has a copy of the proposed text amendment as well as a "red line" and "clean line" version of proposed text amendment including various letters from the MCPC and a detailed memo from his office outlining the issues presenting the timeline of when this application was made and also incorporating comments from Township staff and from the MCPC (Montgomery County Planning Commission).

Commissioner Kline clarified that all of that information will become public once the Board decides to advertise the ordinance. Until then, it is a draft and not considered a public document. Is that correct?

Solicitor Clarke replied that is correct. Until the Board takes action on advertising, all of the documents other than his memo will become public record and can be obtained through a "Right To Know" request.

Commissioner Kline clarified that if the Board decides to advertise proposed text amendment, it would then go back to the Abington Township Planning Commission to review any revisions incorporated into proposed text amendment and go through the entire public process including advertised public meetings. Is that correct?

Solicitor Clarke replied yes.

Commissioner Luker asked for any public comments.

Elizabeth Glaum-Lathbury, 1649 Ferndale Avenue, said she lives behind the property proposed for development and she questioned why a project would be considered at seven times the density of what was just approved as a legislative law. We have confidence that the Commissioners are more concerned about the community and the residents who live in the neighborhood as opposed to the "bottom line" of the development. She is opposed to this development in its current state and she is also concerned about parking and cut-thru traffic in her neighborhood.

Scott Cowperthwait, 1649 Ferndale Avenue, said he also lives behind this property proposed for development and he does not agree with this project and it is not feasible, so he is opposed to this project. He is concerned about drainage issues from that property and proposed text amendment indicates a lesser buffer zone between his property and their property and he is concerned about parking. Also, he expressed concern that proposed development is for student housing and he is opposed to that as well.

Mildred Yarde, 1646 Ferndale Avenue, said she and her husband have lived on Ferndale Avenue since 1984. We like the diversity of our neighborhood; however, there are speeding vehicles coming through the neighborhood, and if we allow this project to happen, there will be more speeding. Also, she expressed concern about the "Stop" sign at Hamilton and Ferndale, which is very confusing to her and we do not agree with this project.

Raymond Bell, 2076 Parkview Avenue, commented that he is opposed to this project because high rise buildings on Old York Road do not make sense to him.

Solicitor Clarke said the developer submitted a draft text amendment on or about October 5, 2017 to Mr. Penecale, and on October 6, 2017, Mr. Penecale contacted the developer's attorney raising several questions requesting clarification on properties affected by the zoning amendment and a plan that would permit calculation of covered setbacks and other dimensional limitations.

Following discussion with attorney for the developers; the Solicitor's office provided a "red line" draft of proposed amendment with revisions on October 24, 2017. One substantive comment concerned a proposed provision allowing the Board of Commissioners to waive zoning requirements and this provision remains in the draft that is before the Board this evening.

The MCPC provided written preliminary comments on the draft ordinance on October 23, 2017 raising several concerns including proposed density. Township staff and the MCPC's staff met with the developer's representative and their attorney on November 16, 2017 following submission by the developer of a revised draft ordinance and this was prepared in response to MCPC's comments.

At the November 16, 2017 meeting with Township staff and the MCPC; we provided comments and recommendations on the revisions to the draft. The MCPC issued its formal comments on the draft ordinance on November 22, 2017 recommending that the Township not enact the ordinance as proposed.

Subsequently on or about the same date as the MCPC's formal comments were made; the developer submitted a newly revised draft responding to comments made at the November 16, 2017 meeting.

On December 12, 2017, the MCPC staff provided informal comments on the latest draft ordinance reiterating the concerns about density and other issues. The most significant concerns from the MCPC, from Township staff and from his office are the proposed provision of the draft zoning amendment, which authorizes the Board of Commissioners to waive zoning provisions.

Any variance from provisions of the Zoning Ordinance must be approved by the Zoning Hearing Board, and despite the fact it has been tweaked on several occasions; it still remains in the draft. The MCPC and Township staff expressed concern that the density as revised increases to 61 dwelling units per acre or 35 units per acre without any bonuses and this is six times the current allowable density. The bonuses related to offsite parking should be contingent upon a firm commitment between the developer and the property owner for the additional parking in which there has not been any commitment that we have been made aware of.

Provision authorizing waiving zoning provisions is problematic given the Zoning Hearing Board's jurisdiction in this regard.

With respect to how this matter should proceed, it would be appropriate that if any Board member needs clarification from the developer and his attorney or the developer's other professionals who are here this evening, it would be appropriate to get that done now. If there are no clarifications there should be a motion to advertise for a public hearing for a subsequent date or a motion to not advertise for a subsequent date, or since this is a discretionary item for the Board, this is within their legislative function as to whether or not to consider the text amendment or the Board can take no action.

Deborah A. Shulski, Attorney with Riley, Riper, Hollin & Colagreco, 717 Constitution Drive, Exton, PA., 19341, agreed that the applicant understood that the Board was going to consider authorizing a public hearing where formal testimony will address concerns such as density, etc. This has been a two-year process where the applicant has been working with Township staff and the Commissioners as well as the neighbors. We were surprised by some of the resident's comments as we reduced the density considerably and we increased buffering and a number of other items. We respectfully request that the Board proceed with advertising a public hearing allowing the applicant to provide testimony.

Commissioner Luker asked for any comments from Commissioners.

Commissioner Kline commented that he is not sure why the Board would consider the proposed ordinance because it is so far from what was discussed by the Zoning Ordinance Rewrite Committee during the rewriting of the zoning ordinance. We carefully considered the northern section of Old York Road such as other sections in Abington because those sections are of major concern. We decided on density and setback requirements and everything related to the northern section of Old York Road, and to see what has been proposed in this text amendment is far and above it as well as with our larger commercial properties. The bonus requirement system in proposed ordinance has no resemblance to any bonus system in the current zoning ordinance.

Also, the contrive qualifiers in proposed ordinance either cause a larger expanse of potential development along the lines of what the zoning ordinance puts together or it creates a spot zoning issue because it eliminates so many different properties, which is problematic. This is not even small tweaks to the MS-H District or H-1 use group; it is a whole different "ballgame" and the new zoning ordinance was just passed earlier this year.

Commissioner Hecker said in committee, it was recommended that this item move forward and his commitment was that this should receive an appropriate review, which is why there were meetings with the neighbors and developer to see whether this was a workable project for both the entities. During the committee meeting, we did not have additional data from the MCPC and his concern is that this would be the first time that this Board would move forward with something that the MCPC is telling us we should not do. He is not comfortable as Commissioner of the ward recommending to his colleagues to move forward on an action when the people we rely on for advice and counsel are telling us it is problematic. There is more discussion needed based on comments made by Township Solicitor and from the MCPC.

Commissioner Myers asked for clarification on the three options for the Board.

Solicitor Clarke replied the first option would be to deny the applicant's request for a hearing; approve request for a hearing or take no action.

Commissioner Myers said if the Board takes no action, does the applicant have an opportunity to come back at a later date with revisions to their plan.

Solicitor Clarke replied the applicant can come back with a revised plan or with the same plan at a future date.

Commissioner Myers said a "no" vote reflected on the record would not help the neighbors as opposed to "no action," and she does not feel she has enough information and that it seems more work needs to be done.

Commissioner Kalinoski commented that "no action" would be the course he would like to take.

Commissioner Luker asked for a motion. There was none.

<u>Reverse Subdivision Plan for Philadelphia Presbytery Homes, Inc. for the property</u> <u>known as the Rydal Waters Site</u>

Commissioner Sanchez made a MOTION, seconded by Commissioner Spiegelman to approve the reverse subdivision and land development plan submitted by Philadelphia Presbytery Homes for the Rydal Water Tract made up of Rydal Way, Noble Circle and Harbison Way zoned within the Senior Neighborhood Residential District of Ward #7.

Commissioner Luker asked for any comments from Commissioners or staff.

Commissioner Luker asked for any public comments on Items CE-02 and CE-03 of the agenda.

Lora Lehmann, 1431 Bryant Lane, expressed concern that she feels this reverse subdivision is about "non-owner, occupied properties," and she is opposed to the motion and text amendment.

Commissioner Sanchez said that reps of Presbytery Homes have met with the neighbors throughout the entire time of this project and worked to satisfy all of their needs and concerns. These are high-end homes where residents have an interest in ownership and they are maintained by Rydal Park. The density is well within what was conceived for this project and it was intended to fit in with existing zoning. It will be a fine addition to assist seniors living in our Township and it also will not be a burden on the School District. He wholeheartedly supports this project.

Nancie Lara, 1248 Huntingdon Road, commented that her father who is now deceased, but was a resident of Rydal Park, and the community there helps increase the independence of the residents and they do an amazing job. She is in favor of a community setting rather than an institutional setting for these adults because there is nothing greater than having a loved one live in an apartment-like setting and she fully supports it.

Commissioner Spiegelman said both Hightop and Presby Homes items have been models for how Commissioners interact with residents when development is proposed, and he commended Commissioners Hecker and Sanchez for it. In regards to Presby Homes; he supports both proposals.

AN ORDINANCE AMENDING CHAPTER 156 – "VEHICLES AND TRAFFIC," ARTICLE II – "TRAFFIC REGULATIONS" SECTION 14 – "STOP INTERSECTIONS" ARTICLE III – "PARKING REGULATIONS" SECTION 25 – "PARKING PROHIBITED AT ALL TIMES; NO PARKING BETWEEN SIGNS; NO PARKING HERE TO CORNER; PARKING PROHIBITED EXCEPT CERTAIN HOURS; NO STOPPING OR STANDING" SECTION 26 – "PARKING PROHIBITED DURING CERTAIN HOURS"

WHEREAS, the Township of Abington is a Township of the First Class, duly organized and existing pursuant to the applicable laws of the Commonwealth of Pennsylvania; and

WHEREAS, pursuant to section 1502.44 of the First Class Township Code of the Commonwealth of Pennsylvania, 53 P.S. §56544, the Board of Commissioners has the authority to enact and amend provisions of the Abington Township Code ("Code") at any time it deems necessary for the health, safety, morals, general welfare, cleanliness, beauty, convenience and comfort of the Township and the inhabitants thereof; and

WHEREAS, pursuant to section 1502.10 of the First Class Township Code of the Commonwealth of Pennsylvania, 53 P.S. §56510, the Board of Commissioners has the authority to take all needful means for securing the safety of persons or property within the Township; and

WHEREAS, pursuant to section 1502.49 of the First Class Township Code of the Commonwealth of Pennsylvania, 53 P.S. §56549, the Board of Commissioners has the authority to regulate parking; and

WHEREAS, the Board of Commissioners of the Township of Abington has determined that Chapter 156 – "Vehicles and Traffic," Article II – "Traffic Regulations," Section 14 "Stop Intersections" and Article III – "Parking Regulations," Section 25 "Parking Prohibited At All Times; No Parking Between Signs; No Parking Here To Corner; Parking Prohibited Except Certain Hours; No Stopping Or Standing" and Section 26 "Parking Prohibited During Certain Hours" should be amended for the health, safety, morals, general welfare, cleanliness, beauty, convenience and comfort of the Township and the inhabitants thereof.

NOW, THEREFORE, the Board of Commissioners of the Township of Abington does hereby ENACT and ORDAIN as follows:

ORDINANCE #2143

AN ORDINANCE OF THE TOWNSHIP OF ABINGTON, MONTGOMERY COUNTY, PENNSYLVANIA AMENDING CHAPTER 152 – "TAXATION" TO ADD ARTICLE VIII – "VOLUNTEER SERVICE CREDIT PROGRAM," SECTIONS 82 THROUGH 91, ESTABLISHING A VOLUNTEER SERVICE CREDIT PROGRAM; ENACTING TAX CREDITS FOR VOLUNTEER MEMBERS OF VOLUNTEER FIRE COMPANIES AND NONPROFIT EMERGENCY MEDICAL SERVICE AGENCIES; AND ESTABLISHING ADMINISTRATIVE PROCEDURES AND APPEALS

WHEREAS, the Township of Abington is a duly organized Township of the first class, existing and operating in accordance with the laws of the Commonwealth of Pennsylvania; and

WHEREAS, in accordance with the First Class Township Code of Pennsylvania, 53 P.S.

§§55101, et. seq., the Township is vested with various corporate powers, including but not limited

to the adoption and enactment of such ordinances and regulations necessary for the proper care,

.management, and control of the Township; and

WHEREAS, the Commonwealth of Pennsylvania recently enacted Act 172 of 2016, which provides municipalities with the option to offer a real estate and/or earned income tax credit to active members of volunteer fire companies and nonprofit emergency medical service agencies through a volunteer service credit program; and

WHEREAS, the Township has determined that the public health, safety and welfare would benefit from the amendment of Chapter 152 – "Taxation," to add Article VIII – "Volunteer Service Credit Program," Sections 82 through 91, creating such a volunteer service credit program.

IT IS HEREBY ENACTED AND ORDAINED by the Township of Abington Board of

Commissioners as follows:

SECTION 1. Amendment to Chapter 152 (Taxation) providing a new Article VIII (Volunteer Service Earned Income Tax Credit and Real Property Tax Credit).

The Township's Code, Chapter 152 (Taxation) shall be amended to add a new Article VIII (Volunteer Service Earned Income Tax Credit and Real Property Tax credit), which shall read as follows:

Article VIII Volunteer Service Earned Income Tax Credit and Real Property Tax Credit

§152-82. Scope and Purpose.

- A. <u>Scope.</u> This Ordinance is related to Act 172 and its intended incentives for municipal volunteers of fire companies and nonprofit emergency medical services agencies.
- B. <u>Purpose.</u> The purpose of this Ordinance is to enact a tax credit against an active volunteer's tax liability as a financial incentive to (1) acknowledge the value and the absence of any public cost for volunteer fire protection and nonprofit emergency medical services provided by active volunteers; and (2) encourage individuals to volunteer, or for former volunteers to consider rejoining as active volunteers, in a township volunteer fire company or nonprofit emergency medical services agency.

§152-83. Definitions

The following words and phrases when used in this ordinance shall have the meanings given to them in this section unless the context clearly indicates otherwise.

"Active Volunteer."	A volunteer for a volunteer fire company or nonprofit emergency medical service agency as indicated herein who has complied with, and is certified under, the Volunteer Service Credit Program as set forth herein.
"Commissioner."	The State Fire Commissioner of the Commonwealth of Pennsylvania.
"Earned Income Tax."	A tax on earned income and net profits levied under Chapter 3

	of the Act of December 31, 1965 (P.L. 1257, No. 511), known as The Local Tax Enabling Act.
"Eligibility Period."	The timeframe when volunteers may earn credit under the Volunteer Service Credit Program.
"Emergency Responder."	A volunteer who responds to an emergency call with one of the volunteer fire companies or nonprofit emergency medical service agencies providing service in Abington Township.
"Emergency Response Call."	Any emergency call to which a volunteer responds, including travel directly from and to a volunteer's home, place of business or other place where he or she shall have been when the call was received.
"Local Tax Enabling Act."	The Act of December 31, 1965 (P.L. 1257, No. 511), known as the Local Tax Enabling Act.
"Qualified Real Property."	A residential real property owned and occupied as the domicile of an active volunteer.
-	A township resident that has served as an active volunteer, in good standing, as so certified under this Ordinance, during the preceding calendar year, for a township volunteer fire company and/or a nonprofit emergency medical services agency.
medical services agency."	An entity that is chartered as a nonprofit corporation and engages in the service of providing emergency medical services to patients within this Commonwealth by operating any of the following:
(((4 (4))))))) (4) (4) (4) (4)	 An ambulance. An advanced life support squad vehicle. A basic life support squad vehicle. A quick response service. A special operations EMS service. This paragraph neludes, but is not limited to: (i) a tactical EMS service; (ii) a wilderness EMS service; (iii) a mass-gathering EMS service; and (iv) an urban search and rescue EMS service. A vehicle or service which provides emergency

	medical services outside of a health care facility, as prescribed by the Department of Health by regulation.
"Tax Credit."	The Earned Income Tax credit and/or the Real Property Tax Credit granted hereunder.
"Township."	The Township of Abington, Montgomery County, Pennsylvania.
"Volunteer."	A member of a volunteer fire company or a nonprofit emergency medical service agency.
"Volunteer fire company."	A nonprofit chartered corporation, association or organization located in this Commonwealth that provides fire protection services and may offer other voluntary emergency services within the Township.
"Volunteer Service Credit Program."	The program established pursuant to this Chapter to determine the active status of a volunteer.

§152-84. Volunteer Service Tax Credits.

- A. <u>Establishment</u>. The Township of Abington hereby establishes a Volunteer Service Credit Program.
- B. <u>Limitations.</u> The tax credits established by this Ordinance may be used against the Qualified Volunteer's tax liability for the current taxable year and every taxable year the individual is qualified as a Qualified Volunteer. The tax credits established by this Ordinance shall remain in effect unless and until the Township repeals this Ordinance.

§152-85. Qualifying Volunteer.

- A. <u>Qualifying Volunteer Criteria.</u> To be a Qualifying Volunteer under this Ordinance, an individual must (1) be a township resident; and (2) have served as an active volunteer, in good standing, as so certified under this Ordinance, during the preceding calendar year, for a township volunteer fire company and/or a nonprofit emergency medical services agency.
- B. Joint Tax Return. An Qualified Volunteer may claim a tax credit provided for in this Ordinance when filing a joint return. The tax return form shall provide a mechanism for separating the liability of an individual for any earned income tax imposed by the school district of residence from the liability of an individual for any earned income tax imposed by the Township. The tax credit shall only be applicable to the earned income tax imposed by the Township.

- C. <u>Injured Active Volunteer</u>. An active volunteer who was injured during a response to an emergency call and can no longer serve as an active volunteer because of the injury and who would otherwise be eligible for tax credits under this Ordinance shall be eligible for such tax credits for the succeeding five tax years. The injured active volunteer must submit a new application each year as set forth herein in order to qualify for the tax credits described herein.
- D. <u>Eligibility Period</u>. The eligibility period for the 2017 calendar year shall be from January 20th through December 31st. For 2018 and subsequent years, the eligibility period shall be from January 1st through December 31st of each calendar year. An active volunteer must meet the minimum criteria, set by resolution of the Board of Commissioners, during the eligibility period to qualify for the tax credits established by this Ordinance.
- E. <u>Recordkeeping</u>. The chief of each volunteer fire company or the supervisor of the nonprofit emergency medical service agency, as applicable, shall keep specific records of each active volunteer's activities in a service log to establish credits under the Volunteer Service Credit Program. Service logs shall be subject to review by the Board of Commissioners of the Township of Abington, the State Fire Commissioner and the State Auditor General. The chief, or supervisor, as applicable, shall annually transmit to the Township Manager a notarized eligibility list of all volunteers that have met the minimum criteria for the Volunteer Service Credit Program. The notarized eligibility list shall be transmitted to the Township no later than January 7th of each year. The chief or supervisor, as applicable, shall post the notarized eligibility list in an accessible area of the volunteer agency's facilities.
- F. <u>Eligibility List.</u> A notarized list of eligible active volunteers shall be submitted to the governing body, no later than 45 days before tax notices are distributed, by the appropriate Chief of the township's five volunteer fire companies or the Township's nonprofit emergency medical services agency, as applicable.
- G. <u>Criteria Revision</u>. The Board of Commissioners reserves the right to revise the criteria for certification of a Qualifying Volunteer, by Resolution, in whole or in part, at its sole discretion.

§152-86. Certification of Qualifying Volunteers.

A. To receive certification as a Qualifying Volunteer under this Ordinance, an individual must meet the Qualifying Volunteer criteria set forth by Resolution and, by January 15 of each year (following the year in which an individual has served as an active volunteer), sign and submit an Application for Certification as a Qualifying Volunteer to the Chief of the volunteer fire company or nonprofit emergency medical services agency, as applicable.

- B. Thereafter, the Fire Company's Chief or the Township's Nonprofit emergency Medical Services Agency Chief, as applicable, shall review all applications submitted, sign each application, and indicate on each application whether he/she recommends the volunteer to be certified as a Qualifying Volunteer.
- C. By January 30 of the same year, the Fire Company's Chief or the Township's Nonprofit emergency medical Services Chief, as applicable, shall forward all applications received, with all supporting documentation, to the Board of Commissioners.
- D. The Board of Commissioners shall review all applications and supporting documentation and shall, by Board motion, certify all Qualifying Volunteers on or before March 1 of each year. Only those volunteers so certified by the Board of Commissioners shall be eligible to receive the earned income tax credit and/or the real property tax credit, and these credits may be utilized for any earned income taxes and/or real property taxes paid or payable to the Township during or for the previous calendar year only.
- E. Official Tax Credit Register. The Township shall keep an official Tax Credit Register of all Qualified Volunteers that were issued tax credit certificates. The Township Manager shall issue updates, as needed, of the official Tax Credit Register to the following:
 - 1. Township Board of Commissioners;
 - 2. Chief of the volunteer fire companies;
 - Chief or supervisor of the nonprofit emergency medical service agency;
 - 4. Tax officer for the Township Tax Collection District.

§ 152-87 – Earned Income Tax Credit

- A. Tax Credit. Each Qualified Volunteer who has been certified under the Volunteer Service Credit Program shall be eligible to receive a tax credit of up to 20% of earned income tax credit per year, not to exceed \$1,000.00 of the of the Township portion of any Earned Income Tax levied by the Township. When an active volunteer's earned income tax liability is less than the amount of the tax credit, the tax credit shall equal the individual's tax liability.
- B. Claim. A Qualified Volunteer with a tax credit certificate may file a claim for the tax credit on their Township earned income tax liability when filing a final local return for the preceding calendar year.

- C. Rejection of Tax Credit Claim.
 - 1. The Township Tax Collector shall reject a claim for a tax credit if the taxpayer is not on the official Tax Credit Register issued by the Board of Commissioners.
 - 2. If the Township Tax Collector rejects the claim, the taxpayer shall be notified in writing of the decision. The notice shall include the reasons for rejection and provide the method of appealing the decision pursuant to Section 89 hereof.
 - 3. Taxpayers shall have 30 days to appeal the decision of the Township Tax Collector.

§ 152-88 – Real Property Tax Credit

- A. Tax Credit. Each Qualified Volunteer who has been certified under the Volunteer Service Credit Program shall be eligible to receive a real property tax credit of 20% of the Township tax liability on qualified real property. This tax credit shall not apply to any other tax liability imposed upon the qualified real property. If the tax is paid in the penalty period, the tax credit shall only apply to the base tax year liability.
- B. Claim. A Qualified Volunteer with a tax credit certificate may file a claim for the tax credit on their qualified real property tax liability for the Township's real estate tax levy. The tax credit shall be administered as a refund. The Qualified Volunteer shall file the following with the Township Manager or the Township Tax Collector:
 - i. A true and correct receipt from the Township real estate tax collector of the paid Township real property taxes for the tax year in which the claim is being filed.
 - ii. The tax credit certificate.
 - iii. Photo identification.
 - iv. Documentation that the tax paid was for qualified real property as defined in this Ordinance.
 - 2. If the active volunteer provides all documents required under this subsection, the Township Treasurer shall issue the tax refund to the active volunteer.
- C. Rejection of the Tax Credit Claim.
 - 1. The Township Tax Collector shall reject the claim for a Township real property tax credit if the taxpayer fails to provide the documents required under Subsection (B).
 - 2. If the Township Tax Collector rejects the claim, the taxpayer shall be notified in writing of the decision. The notice shall include the reasons for the rejection and

provide the method of appealing the decision pursuant to Section 86 hereof.

3. Taxpayers shall have 30 days to appeal the decision of the Township Tax Collector.

§152-89. Appeal.

- A. Earned Income Tax Credit Appeals.
 - 1. Any taxpayer aggrieved by a decision under Section 87 hereof shall have a right to appeal said decision.
 - 2. A taxpayer shall have 30 days to appeal a decision or rejection of claim.
 - 3. All appeals of decisions under Section 87 hereof shall follow the provisions of the Act of May 5, 1998, P.L. 301, No. 50, known as the Local Taxpayers Bill of Rights.
- B. Real Property Tax Credit Appeals.
 - 1. Any taxpayer aggrieved by a decision under Section 88 hereof shall have a right to appeal said decision. A taxpayer shall have 30 days to appeal a decision or rejection of claim.
 - All appeals under Section 88 hereof shall follow the provisions of 2 Pa.C.S. Chapter 5, Subchapter B (relating to practice and procedure of local agencies), and 2 Pa.C.S. Chapter 7, Subchapter B (relating to judicial review of local agency action), also known as the "Local Agency Law."

§152-90. Exemption Certificate.

Within 10 days of the Board of Commissioners decision certifying Qualifying Volunteers, the Township Secretary shall issue a Qualifying Volunteer Exemption Certificate to each Qualifying Volunteer, in a form acceptable to the Tax Collector appointed by the Montgomery County Tax Collection Committee to collect the earned income tax and the Township's Tax Collector elected to collect the township's real property tax.

§152-91. False Reporting Penalty.

A. Any person who knowingly makes, or conspires to make, a false Application for Certification as a Qualifying Volunteer commits a misdemeanor of the first degree punishable by a fine of \$2,500.

B. Any person who knowingly provides, or conspires to provide, a false Certification Recommendation under this Ordinance commits a misdemeanor of the first degree punishable by a fine of \$2,500.

SECTION 2. Repeal and Ratification.

All Ordinances or parts of Ordinances inconsistent herewith or in conflict with any of the specific terms enacted hereby, to the extent of said inconsistencies or conflicts, are hereby specifically repealed. Any other terms and provisions of the Township's Code unaffected by this Ordinance are hereby reaffirmed and ratified.

SECTION 3. Severability

Should any section, paragraph, sentence, clause, or phrase in this Ordinance be declared unconstitutional or invalid for any reason, the remainder of the Ordinance shall not be affected thereby and shall remain in full force and affect, and for this reason the provisions of this Ordinance shall be severable.

SECTION 4. Effective date.

This Ordinance shall become effective 5 days after enactment.

WHEREAS, Act 172 of 2016 provides municipalities with the option to offer a real estate and/or earned income tax credit to active members of volunteer fire companies and nonprofit emergency medical service agencies through a volunteer service credit program; and

WHEREAS, the Board of Commissioners has enacted Ordinance number 2143, which establishes a real estate tax credit and an earned income tax credit to active members of volunteer fire companies and nonprofit emergency medical service agencies; and

WHEREAS, Act 172 of 2016 requires that the Board of Commissioners establish by resolution the annual requirements for the certification of active volunteer service in order to qualify for the tax credits established in Ordinance number 2143; and

WHEREAS, in establishing the requirements herein, the Township has met with the Chiefs of the Abington Fire Company, McKinley Fire Company, Weldon Fire Company, Edge Hill Fire Company, Roslyn Fire Company, and representatives of the Second Alarmers Rescue Squad; and

WHEREAS, in establishing the requirements herein, the Board of Commissioners acknowledges that a volunteer may support a fire company or emergency medical services agency and, therefore, the municipality in many ways, including, but not limited to, (1) response to emergency calls, (2) participation in formal training and drills, (3) administrative and support services, and (4) involvement in events or projects that aid the financial viability, emergency response, or operational readiness; and

WHEREAS, the Board of Commissioners recognizes that the volunteer fire companies that service the Township have established Length of Service Awards Programs ("LOSAP") which provides financial assistance to active volunteers based on longevity of service; and

WHEREAS, the Board of Commissioners supports the existence of, and recognizes the importance of, the LOSAP.

NOW, THEREFORE, BE IT RESOLVED that the Board of Commissioners of Abington Township does hereby establish the following criteria for the certification of active volunteer service:

- 1. Only a person serving in a firefighting, business or Auxiliary function of a volunteer fire company or emergency medical services agency shall be considered a member for purposes of compliance with the terms of this Resolution and/or Ordinance number 2143; and
- 2. A member must be in good standing with the Abington Fire Company, McKinley Fire Company, Weldon Fire Company, Edge Hill Fire Company, Roslyn Fire Company, or the Second Alarmers Rescue Squad; and

- 3. The member has accrued a minimum of 25 hours of service attained by participation in the following activities: response to emergency calls, formal training and drills, administrative and support services, fundraising, or other sanctioned events; and
- 4. The member must demonstrate compliance with all other eligibility criteria or requirements established through Act 172 of 2016 and Ordinance number 2143 are met.

BE IT RESOLVED, that within available resources the Township of Abington will assist all persons who feel they have been discriminated against because of race, color, age, familial status (families with children) religious creed, ancestry, sex, national origin, handicap or disability, use of guide or support animals because of blindness, deafness or physical handicap of the user or because the user is a handler or trainer of support or guide animals, or because of an individual's sexual orientation, gender identity or gender expression to seek equity under federal and state laws by filing a complaint with the Pennsylvania Human Relations Commission and the U.S. Department of Housing and Urban Development.

BE IT FURTHER RESOLVED, that the Township of Abington shall publicize this Resolution and through this publicity shall cause owners of real estate, developers, and builders to become aware of their respective responsibilities and rights under the Federal Fair Housing Law, the Pennsylvania Human Relations Act, and any local laws or ordinances.

FURTHER PUBLICITY will at a minimum include, but not to be limited to: (1) the printing and publicizing of this resolution and other applicable fair housing information through local media and community contracts: (2) distribution of posters, flyers, and any other means which will bring to the attention of those affected, the knowledge of their respective responsibilities and rights concerning equal opportunity in housing.

1106 Old York Road

Solicitor Clarke said property located at 1106 Old York Road was put up for public auction and Township staff is working with the RDA to bid on the auction and was able to obtain the property for less money than originally budgeted for this property. The auction company forward agreement-of-sale to Jerry Nugent of the RDA earlier this morning as there was a 4 p.m. deadline today for agreement of sale to be signed from the auction company, so Mr. Nugent executed the agreement. Once the agreement is signed by the seller and buyer, a deposit must be made within 48 hours, so we need the Board to authorize the payment for 1106 Old York Road so as to not lose this property to the next highest bidder.

Commissioner Spiegelman made a MOTION, seconded by Commissioner Sanchez to approve purchase of 1106 Old York Road from the online auction process including payment of the earnest money deposit through the closing agent upon execution of the purchase and sale agreement by seller and agreement of the remaining purchase price and related closing costs in cooperation with the RDA.

Commissioner Luker asked for the price.

Solicitor Clarke replied that the Township was the highest bidder at 141,000.00 with a five percent (5%) fee to the auction company, so total owed is \$148,050.00.

Commissioner Gillespie asked for the amount of earnest deposit.

Commissioner Sanchez replied \$4,230.00.

Commissioner Spiegelman said this was late breaking and the Board is familiar with the Old York Road/Susquehanna project and it is a huge step forward. He urged his colleagues to please consider supporting this action.

MOTION was ADOPTED 14-0.

FINANCE COMMITTEE:

Treasurer's Report:

Township Treasurer Jay W. Blumenthal noted that his report is before the Board this evening and he will answer any questions.

Investments

Commissioner Kline made a MOTION, seconded by Commissioner Hecker to approve investments for the month of October as previously circulated to the Board. It was noted that investment for the month totaled \$735,000.00. Interest rate yields were 1.250%.

Commissioner Luker asked for any comments from Commissioners or staff. There were none.

MOTION was ADOPTED 14-0.

Expenditures/Salaries and Wages

Motion to:

- (A) Approve the October expenditures as previously circulated to the Board, in the amount of \$5,048,516.19 and salaries and wages in the amount of \$1,818,342.99.
- (B) Authorize the proper officials to sign vouchers in payment of bills and contracts as they mature through the month of January 2018.

Commissioner Luker asked for any comments from Commissioners or staff. There were none.

Roll call resulted in motion being passed 14-0. Commissioner Bowman was absent during roll call.

Training and Conference Expenses

Commissioner Kline made a MOTION, seconded by Commissioner Hecker to approve the Advance and Travel Expense activity for October 2017 as previously circulated to the Board. Advance and Travel Expense reports were \$0.00 and \$2,422.38, respectively. Ten-month expenses totaled \$25,252.31.

Commissioner Luker asked for any comments from Commissioners or staff. There were none.

Clearing Fund/Deferred Revenue and Expenses/Petty Cash

Commissioner Kline made a MOTION, seconded by Commissioner Farren to approve the Clearing Fund, the Deferred Revenue/Expense activity and Petty Cash balances for the month of October as previously circulated to the Board.

Clearing fund receipts and disbursements for the month of October 2017 were \$845.31 and (\$2,234.34), respectively.

Deferred Revenue/Expense receipts and disbursements for the month of October 2017 were \$40,000.00 and (\$93,349.00), respectively.

Commissioner Luker asked for any comments from Commissioners or staff. There were none.

MOTION was ADOPTED 14.0.

Budget Transfer Authorization

Commissioner Kline made a MOTION, seconded by Commissioner Hecker to authorize the Budget Transfers and Supplemental Appropriations going from fund balance to the appropriate departmental personal service expense cost objects for the Fiscal Year 2017.

Commissioner Luker asked for any comments from Commissioners or staff. There were none.

MOTION was ADOPTED 14.0.

Funding for Legal Fees

Commissioner Hecker made a MOTION, seconded by Commissioner Spiegelman to appropriate \$100,000.00 from fund balance for legal fees.

Commissioner Luker asked for any comments from Commissioners or staff.

Commissioner Kline said he will recuse himself from voting on this item.

Commissioner Myers commented that she will not vote against this, but will do so with reservation. This is beginning to be a money pit and we are always hearing about it after the money has been billed, invoiced or spent. Where does it fit in with the fund balance policy and is there any money remaining in contingency fund that could cover a portion of it?

Manager Manfredi replied there are no funds available in contingency and it needs to come from fund balance.

Kevin Barron, Finance Director, said he hopes that \$100,000 is not needed. He brought this matter before Finance Committee estimating expenditures through the years and came up with this figure and he does not want to come back before the Board asking for more. Only what is needed will be transferred, not the entire \$100,000.00, so the motion should say, "up to and including \$100,000.00."

Commissioner Myers clarified that this is to cover invoices that were submitted. Is that correct?

Mr. Barron replied this is to cover invoices for October, November and December for which he does not have yet.

Commissioner Myers clarified that this amount will cover those invoices not yet received. Is that correct?

Mr. Barron replied absolutely.

Commissioner Myers asked how much was budgeted next year for legal fees?

Mr. Barron replied the same amount as 2017.

Commissioner Myers said it would behoove the Board to have some type of policy for legal fees. This is not a good way to operate taking \$100,000 from fund balance in the middle of December to cover invoices that have not been submitted yet and it is concerning.

Manager Manfredi replied there is a retainer that covers work done by the attorney, and before the Board approves any matter of litigation, the Solicitor should project out the costs that are not covered under that retainer. So on a case-by-case basis, funds can be authorized by the Board to withdraw from contingency or fund balance to cover anything outside of the retainer.

Fire Company Audit Award

Commissioner Kline made a MOTION, seconded by Commissioner Hecker to authorize the President of the Board of Commissioners and Township Manager to execute a threeyear agreement with Maillie Falconiero & Co. for purposes of providing fire audit services for the years 2017 in the amount of \$19,000, 2018 in the amount of \$19,500 and 2019 in the amount of \$20,000. Funds to be drawn from Fire in-lieu-of taxes.

Commissioner Luker asked for any comments from Commissioners or staff. There were none.

MOTION was ADOPTED 14.0.

PENSION COMMITTEE:

<u>Resolution No. 17-030 – Amending Police Pension Document Pertaining to Member</u> <u>Contributions</u>

Commissioner Kline made a MOTION, seconded by Commissioner Spiegelman to set Police Pension contribution rate for 2018 at five percent (5%) of compensation.

Commissioner Luker asked for any comments from Commissioners. There were none.

RESOLUTION NO. 17-030

AMENDING POLICE PENSION PLAN DOCUMENT PERTAINING TO MEMBER CONTRIBUTIONS

WHEREAS, the Township of Abington (the "Employer") previously established, by Resolution dated January 1, 2001, the Police Pension Plan for the Township of Abington (the "Plan"); and

WHEREAS, the applicable statute provides that the establishment of such pension plan may be made by Ordinance or Resolution; and

WHEREAS, the "Employer" does, in fact, from time to time, modify and/or amend the "Plan"; and

WHEREAS, any and all amendments and modifications to the "Plan" are required to adhere to all regulations as per applicable pension law (Act 600); and

WHEREAS, the "Employer", through negotiation with the Abington Township Police Association, have made it necessary and desirable to amend Article III entitled "Contribution", Section 3.01 entitled "Member Contributions", and

WHEREAS, this amendment will be effective January 1, 2018;

NOW, THEREFORE, BE IT RESOLVED, this 14th day of December, 2017, that Article III, Section 3.01 shall be amended in its entirety to read as follows:

ARTICLE III

CONTRIBUTIONS

3.01 <u>Member Contributions</u>. MEMBERS shall pay into the FUND a percentage amount to be determined annually based upon the most recent actuarial report and minimum municipal obligation calculation. The percentage rate will be set annually by resolution no later than December 31st for the following calendar year. The percentage rate shall be set between zero (0%) and five percent (5%) of COMPENSATION. The contribution rate for 2018 is five percent (5%) of COMPENSATION. It is further understood that the TOWNSHIP will not contribute into the FUND until the MEMBERS are contribution by MEMBERS shall be maintained, including all interest credited to the MEMBER'S individual account which shall be known as the MEMBER CONTRIBUTION ACCOUNT. Interest to be credited shall be five percent (5%) compounded annually.

Interest shall be credited from the end of the PLAN YEAR in which paid to the end of the month after which a refund becomes payable.

RESOLUTION NO. 17-031 Amending Resolution No. 17-025

REVISED MINIMUM MUNICIPAL OBLIGATION FOR 2018 MUNICIPAL NON-UNIFORMED EMPLOYEES' DEFINED CONTRIBUTION PENSION PLAN

WHEREAS, the Township of Abington does maintain three pension plans;

WHEREAS, said plans are known as the Township of Abington Municipal Non-Uniformed Employees' Pension Plan, the Township of Abington Police Pension Plan and the Township of Abington Non-Uniformed Employees' Defined Contribution Pension Plan;

WHEREAS, Act 205 of 1984 mandates that the governing body of said "plans" recognize their minimum obligation on or before September 30 of a given year;

WHEREAS, Act 205 of 1984 allows the governing body of said plans to revise and amend their minimum municipal obligation on or before December 31 of a given year;

NOW, THEREFORE, BE IT RESOLVED, that based upon employee contributions at 5% for the calendar year 2018, the Board of Commissioners amends the funding requirements as enacted September 14, 2017 for the Municipal Non-Uniformed Employees' Defined Contribution Pension Plan to be \$53,486.

THEREFORE, the Board of Commissioners recognizes these funding requirements and makes provisions for these costs as part of their budget for the year 2018.

There are EPA and FDA guidelines for lasers as laser is a device that emits light through a process of optical amplification based on stimulated emission of electromagnetic radiation. The FDA classifies lasers as most hazardous and she respectfully asked the Board to consider a code guideline with respect to decorations.

Lora Lehmann, 1431 Bryant Lane, asked for documents of legal fees in regards to the Briar Bush project. Also, she was opposed to the "Fire Tax Credit passed without an amount assessed to it."
