WHEREAS, proper notice of the public hearing held on this date was published as required.

Now, Therefore, Be It Resolved, that Movie Grill Concepts XLIII, LLC has requested the approval of the Township of Abington Board of Commissioners for the proposed transfer of Pennsylvania Restaurant Liquor License No. R-13874 (1708 Limekiln Pike, LLC, 1708 Limekiln Pike, Upper Dublin Township, Dresher, Montgomery County, Pennsylvania 19025-1503) by Movie Grill Concepts XLIII, LLC to a restaurant facility within the Township of Abington to be located at Willow Grove Park Mall, 2500 W.
