- 3. Pending grant- TV Watershed 2019- \$3244 grant with \$4766 match for project total of \$8010
  - a. adjustments to watershed grant described by Rita
- 4. **New:** Pending memorial donation- memorial bench plus \$1000 budget for plantings at Ardsley Wildlife Sanctuary
  - a. township resident offering a bench and funds for trees and plant materials at the AWS site
- 5. **New:** Potential for funds to support tree giveaway at Abington Manor (similar to CSX 2017 event)
  - a. initial efforts underway for additional planting in the Abington Manor area

#### **ADVISORY**

- New: Review and comment on Land Development Application LD-19-01: Proposed existing building revisions and parking lot at the Southeast Corner of Highland and Kenmore Ave
  - a. Rita laid out and described the process for gathering feedback from the SRC and providing this to township officials. The commission reviewed the landscape plans including suggested plant list.
  - Initial feedback that there could be more large canopy trees included. Shade tree commissioner Carl will complete a site visit and report back via email.

- Ongoing: Street Tree master plan for TC street trees- continue to frame what's needed to develop a recommendation; Supporting tool- PHS Urban Tree Cloud for tree inventory https://pg-cloud.com/phs/; immediate recommendations for corner of Keswick and Mt Carmel, and for Keswick Village holiday tree
  - a. Oriental or Serbian spruce recommended for Keswick Village
  - b. Street tree plan discussed for Keswick area-history of no maintenance and poor cutting regiment. Is this an opportunity to research and create a best practice?
- 3. Land Development Application for new Medical Office at 1137-51 Old York Road continue to watch

  new item: Discuss proposed memorial project
