Eastern Montgomery County Waste System Authority Disposal of Assets

Commissioner Bowman made a MOTION, seconded by Commissioner Spiegelman to accept the Waste System Authority's proposed disposition of assets and authorize the execution of a mutual release from any liabilities or obligations related to those funds.

Commissioner Luker asked for any comments from Commissioners or staff.

Commissioner Sanchez said the motion calls for a mutual release and the actual release says that the Township is releasing the County. Is this final or can the Township negotiate it?

Solicitor Clarke replied it is a formal lease drafted by reps of the County for all 22 municipalities and, while its termed a "mutual release," the Township is releasing the County and the County does not need to release the Township of anything.

Commissioner Sanchez asked is there an opportunity for the County to release the Township from any liabilities or obligations related to those funds?

Solicitor Clarke replied if the Board wants him to revise some of the language, he will do that, but this lease has been submitted to all 22 municipalities and he is not sure whether the County would want a different lease for just this Township.

Commissioner Sanchez said he will vote in favor of it, but he asked for that to be investigated.

Solicitor Clarke replied if the Board would like to approve it tonight with the idea that some of the language will be revised to reflect an actual mutual release that will be done, although there would not be any cause of action taken against the Township regarding the assets.

Commissioner Kline commended the County, Waste System Authority Board and especially Manager LeFevre for this agreement as it is a good solution that will work out for all municipalities involved.

Manager LeFevre commented that it is the most equitable solution for all parties involved and a fair agreement.

Commissioner Luker asked for any public comments. There were none.

Radiation Equipment - Abington Transfer Station

Commissioner Bowman made a MOTION, seconded by Commissioner Gillespie to accept the Waste System Authority's offer of \$50,000 for the replacement of the radiation detection equipment at the transfer station and authorize the Board President to execute a release of all claims related to the same.

Commissioner Luker asked for any comments from Commissioners or staff.

Commissioner Sanchez questioned whether this agreement should be a mutual release as well.

Manager LeFevre explained that the County leased the property from the Township for the past 25 years and, at the end of the lease, all fixed assets are returned to the property owner, which is the Township. The radiation equipment is still operable, but approaching the end of its useful life and the County has recognized that and made an offer of \$50,000 payment to the Township to replace that equipment when the need arises. The consulting engineer estimated that cost at \$35,000, so it seems to be a generous offer.

Solicitor Clarke added that the Township is releasing the Waste System Authority and they will cease to exist because the County has terminated that Board. However, he will discuss with the Waste System Authority's Solicitor about a mutual release.

Commissioner Luker asked for any public comments. There were none.

MOTION was ADOPTED 15-0.

Solid Waste Disposal Services Contract

Commissioner Bowman made a MOTION, seconded by Commissioner Hecker to approve as amended the Solid Waste Disposal Services contract between Abington Township and Covanta.

Commissioner Luker asked for any comments from Commissioners or staff.

Commissioner Kline asked for an explanation of the amendment.

Solicitor Clarke replied the original agreement that the Board approved last month contained certain language where Covanta will still be required to pay lease amounts, but Covanta noticed after they agreed to sign it that it did not have any language regarding circumstances out of their control such as acts of God, fire, explosion, etc. or anything else not caused by Covanta or by one of their contractors, so they asked for that language to be included. However, that language was referenced in the original bid documents, but was not included in the original contract.

The Tax Office collected in real estate taxes for December 2014, \$95,956 representing a decrease over prior year of (\$1,958). Balance to be collected was \$493,265 with 2% remaining.

The books are now closed and he will take the lien list to the County. For those who have not paid their taxes by the end of the year they will be collected by a third party organization.

Business tax returns will be sent out tomorrow or early next week and real estate tax bills will be sent out end of January, beginning of February.
