PUBLIC COMMENTS ON AGENDA AND NON-AGENDA ITEMS:

Lora Lehmann, 1431 Bryant Lane, congratulated the incoming Commissioners and she "hopes for great new things" and she asked the Board "to bring in a new Solicitor."

Election of Officers -

Nominations for the Office of President:

Manager Manfredi opened the floor for nominations for the Office of President.

Commissioner Rothman nominated Commissioner John Spiegelman as President, seconded by Commissioner Luker.

Commissioner Myers made a MOTION to close nominations, seconded by Commissioner Hecker. Nominations were closed by a vote of 14-0.

MOTION to appoint Commissioner John Spiegelman as President of the Board of Commissioners of the Township of Abington – PASSED 14-0.

Nominations for the Office of Vice President:

President Spiegelman opened nominations for the Office of Vice President.

Commissioner Zappone nominated Commissioner Tom Hecker as Vice President, seconded by Commissioner Bowman.

President Spiegelman asked for any other nominations. There were none.

Commissioner Thompson made a MOTION to close nominations, seconded by Commissioner Bowman. Nominations were closed by a vote of 14-0.

MOTION to appoint Commissioner Thomas Hecker as Vice President of the Board of Commissioners of the Township of Abington – PASSED 14-0.

Vice President Hecker said he never imagined that there would be another opportunity to be engaged in public service for Abington Township. He previously served as Ward 10 Commissioner, and in August 2018, moved from where we lived for 15 years into Meadowbrook for family reasons. When this opportunity arose to get back involved with stellar people serving on this Board and to be involved in shaping the future of this community, he is delighted to be here. He is humbled by the opportunity to serve in leadership and appreciates the trust that all of you have demonstrated in electing him to this role and he promises to not let you down. Thank you.

President Spiegelman said every time we take a step up here and take our seats we truly stand on the shoulders of giants of both political parties. He thanked our President Emeritus, one of the most decent gentleman he has ever known, his mentor and friend, Commissioner Wayne Luker for everything.

In the audience tonight is his wife Ester Eichler, a 25-year Teacher with the Abington School District and sitting next to her are his parents, Doctors Joyce and Morton Spiegelman and his father-n-law, Herbert Eichler, the German Engineer. Having them here tonight means more to him than he could ever articulate and they have among them 276 years and counting of life experience and they are joined in representation by the spirit of his late mother-n-law Gert Eichler who is always with him as a guiding spirit.

Over the course of the past two years or so, Ester and he moved their parents from out-ofstate to Abington Township doubling the footprint of our little family, and we brought them here because we love this community as it is a remarkable and very special place.

As he began going door-to-door and meeting people, there was so much cynicism, mistrust and the idea of public service had been degraded in people's mind, and he wanted people to know that there was at least one person that cared about them personally and their family personally and he worked very hard towards that goal.

We, on this Board, cannot control what happens in Washington D.C. or in Harrisburg, but we can and we are, especially moving forward, an example of how to do things the right way, the respectful way, the open way, the transparent way, the accessible way and the truthful way and that is a commitment he makes to everyone here and everyone watching.

He likes it when people ask questions of the Board and challenge us and it is important to speak truth to power and that begins with truth. We owe it to each other to be open, honest and engaged. Part of the oath means we are under obligation to be truthful, honest and open with all of you and he hopes that everyone who engages with the Board will do the same. We are all neighbors and part of the Abington Township family and we owe it to each other to be honest, respectful and try to be kind and set an example for the crazy world we see around us every single day in the news.

Every person up here is dedicated to the wards and the neighborhoods that they represent and this Board is an incredibly diverse panel of all different backgrounds and it is important for all of us from this day forward to go out of our way to be good listeners and to reach out to every neighbor in the community and listen respectfully to everyone's hopes, fears, thoughts, concerns and aspirations. It is his deep honor to be here and he is grateful to our amazing community. Thank you.

President Spiegelman asked for any comments from Commissioners. There were none.

MOTION was ADOPTED 14-0.
