PRESENTATIONS:

Commissioner Schreiber stated that for the past few months she has heard over and over again from many different people how much Vice President Steven Kline will be missed on the Board of Commissioners. Steven is the most detailed-oriented person she has ever met. Almost every single large project that this Township has taken on has benefited from his input. Mostly everyone sees Steven as he appears at the meetings, but what some might not know is his willingness to help behind the scenes. Probably most of the Commissioners can think of some project in their ward that he offered to help with or to meet and give advice. He is generous with his time and has a wealth of knowledge on everything from planning, zoning and budget concerns, which has helped us all. For her personally, she will always be grateful for his help with the Anti-Discrimination Ordinance, and as many of you know, it hit an impasse and Steven was the person who brokered the final push to have that important piece of legislation finally moved forward, and she thanked him for it. She and the Board will miss him, but she knows this will be the beginning of a new adventure.

President Luker presented Vice President Steven N. Kline with Citation as follows:

Steven N. Kline was first sworn into office of Township Commissioner of Ward 1 in January 2008 and has served three terms. Mr. Kline in addition to his twelve years as a Commissioner has also served on the Planning Commission, Public Works, Code Enforcement and Public Affairs Committees, including serving as Chairman of the Finance and Pension Committees.

Township Commissioner Steven Kline has represented the people of Ward 1 with distinction and was instrumental in revising the Township's Zoning Ordinance, key in developing the fund balance policy and served as Vice President since 2014.

On this 12th day of December 2019, that Steven N. Kline be remembered for these and many accomplishments and achievements, and for serving the people of the Township of Abington, with honor and integrity, and is herewith recognized by this formal expression of gratitude and thanks, by the Township Board of Commissioners of the Township of Abington.

Commissioner Myers stated that Commissioner Carol Gillespie followed her husband former Commissioner Mike Gillespie, and when he passed, Carol stepped up to plate and became Commissioner, because when you live with a Commissioner, you can do the job, and she proved that she could. Carol has been amazing to her community, and in order to keep the Glenside Parade going, in which she has been on that committee for many years also following in Mike's footsteps, she developed and founded a 5K Run to pay for much of that parade. Each year she worked to increase the funding from that run for the parade, and this past year, she raised \$19,000 to keep the parade running.

Between Mike and Carol, they have given 60 years of service to this community and that is incredible and something to be proud of. Abington Township has a very good friend in Carol Gillespie and so do we. She thanked Commissioner Carol Gillespie for her years of service as a Commissioner and her service will not stop here as she is a trooper and will keep on going and keep on giving to the Township that she loves.

President Luker presented Commissioner Carol E. Gillespie with Citation as follows:

Carol E. Gillespie was first sworn into office of Township Commissioner for Ward Thirteen on the 9TH day of July 2009, following the passing of her late husband, Commissioner Michael Gillespie, again on the 4thday of January 2010, on the 3rdday of January 2012, and the 21st day of January 2016.

Ms. Gillespie has served as a member on the Public Works, Code Enforcement, Public Affairs and Public Safety Committees.

Township Commissioner Gillespie has represented the people of Ward 13 with distinction and always considered those she served.

On this 12thday of December 2019, Carol E. Gillespie will be remembered for her many accomplishments and achievements and for serving the people of the Township of Abington with honor and integrity, and is herewith recognized by this formal expression of gratitude and thanks by the Township Board of Commissioners of the Township of Abington.

President Luker read statements into the record from State Representative Ben Sanchez to Commissioner Gillespie and Vice President Kline thanking them for their many years of service to Abington Township.

PUBLIC COMMENT ON AGENDA ITEMS:

Lora Lehmann, 1431 Bryant Lane, expressed concern about not having enough time to speak about the budget.

Natalie Sherstyuk, 1165 Delene Road, expressed concern about how pensions were funded, which accounts for the 10% tax increase and it is not the right time to spend on the redoing of this municipal complex.

Drew Sharkey, Cheltenham Township Commissioner, congratulated Vice President Kline for his 12 fantastic years of service and he thanked Steven for it. Also, to his good friend, he thanked Commissioner Gillespie for her and her husband's combined 60 years of service.

Adam Zucker, Vice Chairman of the Board of Supervisors of Whitpain Township, expressed his gratitude to Vice President Kline who has been a great public servant to his parents who lived in Ward 1 for many years and he thanked Steven for his responsiveness to his parents who always held Steven in the highest regard and had the highest respect for him.

Jessica Ram, resident of Conshohocken, provided a handout to the Manager in regards to the Covanta facility in Conshohocken that repeatedly malfunctions, which is an incinerator that burns municipal waste located within a mile of her home. The facility malfunctions producing loud noises followed by a noxious smell blanketing the community, and Covanta denied every malfunction with the exception of one where DEP issued a notice of violation back in October. She requested that the Township not renew its contract with Convanta.

Commissioner Schreiber questioned whether this item should be removed from consent agenda.

Manager Manfredi replied the item listed is only to extend existing contract for three months while we evaluate whether or not to renew the contract.

Commissioner Spiegelman asked for research to be done on the information shared with the Board as there is cause for concern.

Finance Committee –

Receive Treasurer's Report:

Township Treasurer Jay W. Blumenthal reported that deposits of real estate taxes transferred to Finance Department for November 2019 were in the amount of \$32,043; YTD \$24,531,697 leaving a balance to be collected of \$3,366,675. Monies received from various departments deposited into Republic Bank in November 2019 were in the amount of \$2,522,258 as compared to last year of \$4,954,831 representing a decrease of (\$2,432,573); YTD \$61,493,384 as compared to last year of \$62,281,341 representing a decrease of (\$787,957).

Item FC-01-121219:

Commissioner Vahey made a MOTION, seconded by Commissioner Winegrad to approve the October expenditures as previously circulated to the Board in the amount of \$3,873,139.89 and salaries and wages in the amount of \$1,923,269.87 and authorizing the proper officials to sign vouchers in payment of bills and contracts as they mature through the month of January 2020.

Roll call resulted in motion being passed 15-0.

Item FC-04-121219:

Commissioner Vahey made a MOTION, seconded by Commissioner Winegrad to authorize the Budget Transfers and supplemental appropriation for the Fiscal Year 2019.

President Luker asked for any comments from Commissioners or staff. There were none.

MOTION was ADOPTED 15-0.

Item FC-05-121219:

Commissioner Vahey made a MOTION, seconded by Commissioner Winegrad to authorize Township Officials to enter into an agreement with Bee, Bergvall & Co. to act as Township's independent auditors for calendar years ending December 31, 2019, 2020 and 2021.

President Luker asked for any comments from Commissioners or staff. There were none.

MOTION was ADOPTED 15-0.

Item FC-08-121219:

Commissioner Vahey made a MOTION, seconded by Commissioner Winegrad to rescind the July 14, 2016 authorization of the Abington Township Board of Commissioners (BOC) to enter into a contract with AH Adams & Company (AHA) for accessibility modifications at the Ardsley Community Center due to a change in scope of work; and to approve and authorize the Township Manager to execute a contract with Kd2 Architects, Inc. in the amount of \$5,800.00 to prepare construction drawings for the installation of a new wheelchair lift at the Ardsley Community Center.

President Luker asked for any comments from Commissioners or staff. There were none.

MOTION was ADOPTED 15-0.

Item FC-09-121219:

Commissioner Vahey made a MOTION, seconded by Commissioner Gillespie to create and adopt a policy for an Affordability Period for the Township's housing programs (rental and homeownership) operated by Community Development; and to the releasing of liens placed by the Township on various rental properties owned by the Willow Grove Community Development Corporation, a local nonprofit housing provider, as stated in the July 3, 2019 letter.

President Luker asked for any comments from Commissioners or staff.

Commissioner Winegrad asked for further explanation.

Manager Manfredi replied this was discussed at the Finance Committee meeting with representatives of the Willow Grove Community Development Corporation and it was questioned whether the liens were to be released through legal agreements. Since then, supporting documents have been received indicating the liens should be released and Township Solicitor's Office recommended that a policy be created and the motion is to authorize the creation of a policy that will be brought before the Board of Commissioners to discuss how this should be handled going forward.

MOTION was ADOPTED 15-0.

PUBLIC COMMENT:

Matt Schick, 941 Wesley Avenue, commented that when he thinks about servant leadership he thinks about Commissioner Gillespie. This past year, he had the pleasure to help Commissioner Gillespie and he has seen her inclination to help her neighbors and that she became a Commissioner for her community that she loves. He thanked Commissioner Gillespie for her and her family's years of dedicated servant leadership and for all that she has done for his family, himself and everyone of the Township of Abington.

Lora Lehmann, 1431 Bryant Lane, wished Commissioner Gillespie a wonderful retirement and thanked her for her service on this Board.

Rebecca Kline, 940 Washington Lane, thanked her father Steven Kline for all that he has done for our community over the past few years and for fueling the fire in her since she was little to try her best to help as many as people as she can. She thanked him for raising her politically and socially-minded, and she and her family are very proud of him. She also thanked Commissioner Gillespie for all that she has done.

Natalie Sherstyuk, 1165 Delene Road, expressed concern about the pension fund being under funded and that is the main reason for the tax increase.

Walter Draving, 1431 Bryant Lane, asked for the total amount of items on the "wish list."

Commissioner Spiegelman replied about \$500,000.

Jessica Ram, resident of Conshohocken, expressed concern about "not feeding Montgomery County's number one polluter."

REMARKS OF COMMISSIONERS:

Commissioner Bowman gave his appreciation to outgoing Commissioners Kline and Gillespie for their many years of service to this Board.

Commissioner Zappone announced that this Sunday, the Ardsley Community Association will be holding its 8th Annual Breakfast with Santa at the VFW Post 676 from 9-noon.

Commissioner Gillespie said it has been an interesting 10 years including her late husband Mike's 18 years prior to that and she always knew what was going on. She thanked everyone who works for the Township as they do an excellent job. She also thanked the volunteer firefighters and she is very proud of the Township she lives and works in. Also, she wished everyone on the Board "Good Luck" in their years ahead.

Commissioner Vahey said to Commissioner Gillespie: "It has been a real privilege serving next to you in our neighboring wards and sitting next to you on the Board. Carol has helped bring balance to some tense situations and I appreciate that as well as our friendship."

To Commissioner Kline: "You can be a challenge, but you challenge us all to do a lot better job and I don't think I could be doing the job I am doing today without your guidance, so I really appreciate all you have to done for us in this Township. Thank you."

Commissioner Spiegelman said to Commissioner Gillespie: "It has been a pleasure to get to know you and I respect that you not only continue to honor the Gillespie legacy for your great husband Mike, but also to continue making it your own, and I wish you All the Best."

Commissioner Myers said to Commissioner Gillespie: "Carol, it will be very hard not to look across the Board and not see you there and hear your infectious laugh. It has been a delight working with you and the best part is we will continue to be great friends."

She wished everyone a "Healthy New Year!" It has been a challenging year for her loved ones and everyone has been so incredibly kind and generous and very good to her especially those she works with including Township staff who have also been very kind and she appreciates it. Thank you.

Commissioner Brodsky said to Commissioner Gillespie: "Carol, we have only known each other for several years, but recently you have been more than lively on the Board and I appreciate that and "Good Luck" in your future endeavors and future retirement."

To Commissioner Kline: "You are a ward neighbor and I have known you for longer than most people realize and your service and dedication to the Board and Township are much appreciated. It has been a pleasure working with you and an honor, and you have always been there."

RESOLUTION NO. 19-028

AMENDING POLICE PENSION PLAN DOCUMENT PERTAINING TO MEMBER CONTRIBUTIONS

WHEREAS, the Township of Abington (the "Employer") previously established, by Resolution dated January 1, 2001, the Police Pension Plan for the Township of Abington (the "Plan"); and

WHEREAS, the applicable statute provides that the establishment of such pension plan may be made by Ordinance or Resolution; and

WHEREAS, the "Employer" does, in fact, from time to time, modify and/or amend the "Plan"; and

WHEREAS, any and all amendments and modifications to the "Plan" are required to adhere to all regulations as per applicable pension law (Act 600); and

WHEREAS, the "Employer", through negotiation with the Abington Township Police Association, have made it necessary and desirable to amend Article III entitled "Contribution", Section 3.01 entitled "Member Contributions", and

WHEREAS, this amendment will be effective January 1, 2020;

NOW, THEREFORE, BE IT RESOLVED, this 12th day of December, 2019, that Article III, Section 3.01 shall be amended in its entirety to read as follows:

ARTICLE III

CONTRIBUTIONS

3.01

Member Contributions. MEMBERS shall pay into the FUND a percentage amount to be determined annually based upon the most recent actuarial report and minimum municipal obligation calculation. The percentage rate will be set annually by resolution no later than December 31st for the following calendar year. The percentage rate shall be set between zero (0%) and five percent (5%) of COMPENSATION. The contribution rate for 2020 is five percent (5%) of COMPENSATION. It is further understood that the TOWNSHIP will not contribute into the FUND until the MEMBERS are contributing their maximum of five percent (5%) of their COMPENSATION. Individual records of contribution by MEMBERS shall be maintained, including all interest credited to the MEMBER'S individual account which shall be known as the MEMBER CONTRIBUTION ACCOUNT. Interest to be credited shall be five percent (5%) compounded annually.

Interest shall be credited from the end of the PLAN YEAR in which paid to the end of the month after which a refund becomes payable.

TOWNSHIP OF ABINGTON

AN ORDINANCE AMENDING CHAPTER 156 – "VEHICLES AND TRAFFIC," ARTICLE II – "TRAFFIC REGULATIONS," SECTION 9.2 – "NO LEFT TURN," SECTION 11 – "TURNS AT INTERSECTIONS," SECTION 14 – "STOP INTERSECTIONS"; AND ARTICLE III – "PARKING REGULATIONS" SECTION 25 – "PARKING PROHIBITED AT ALL TIMES; NO PARKING BETWEEN SIGNS; NO PARKING HERE TO CORNER," SECTION 28 – "SPECIAL PURPOSE PARKING ZONES"

WHEREAS, the Township of Abington is a Township of the First Class, duly organized and existing pursuant to the applicable laws of the Commonwealth of Pennsylvania; and

WHEREAS, pursuant to section 1502.44 of the First Class Township Code of the Commonwealth of Pennsylvania, 53 P.S. §56544, the Board of Commissioners has the authority to enact and amend provisions of the Abington Township Code ("Code") at any time it deems necessary for the health, safety, morals, general welfare, cleanliness, beauty, convenience and comfort of the Township and the inhabitants thereof; and

WHEREAS, pursuant to section 1502.49 of the First Class Township Code of the Commonwealth of Pennsylvania, 53 P.S. §56549, the Board of Commissioners has the authority to regulate traffic and parking; and
