EDC meetings are essentially a workshop environment for ED policies, programs, or projects which develop over a considerable length of time. When finalized, programs and projects are presented for public discussion to the Commissioners under the Public Affairs agenda. As such, minutes are summary in nature and not verbatim.

Agenda Item EDC - 1: Welcome

Chairman Doug Callantine opened the meeting by welcoming the committee and guests. There was a moment of silence for Jack Thalheimer who passed away following a sudden illness. Jack shared 22 years with the EDC and most recently became Chairman Emeritus in July 2014. Jack's dedication and loyalty to the EDC and Abington community will certainly be missed.

Agenda Item EDC - 2: Penn State Housing

- a. Penn State Abington Presentation to EDC June 2, 2015 7:00PM.
- b. Abington Township has received an application for a "zoning text amendment" submitted on behalf of Penn State Abington. The zoning text amendment seeks to add a proposed new "Use H-1.A Student Apartment Housing" to the Township's existing Planned Business District zoning code designation.

Agenda Item EDC - 3: EDC Interviews for vacant seats

The EDC currently has two (2) vacant seats. There was a subcommittee that conducted five (5) interviews on 4/28/15.

On behalf of the interview committee, Doug Callantine recommended Mike McPaul and Randee Elton to be the candidates to fill the open EDC seats. Both of these individuals are well qualified to support the work of the EDC and each possess attributes the EDC has established for candidates including expertise and experience in regional/urban planning, real estate, financial analysis, and grant writing.

Wendy Klinghoffer made the motion for the 2 proposed candidates, Mike McPaul and Randee Elton, to be approved by the EDC to recommend to the full Board of Commissioners for appointment. This motion was seconded by Bruce Goodman and the EDC unanimously agreed. Doug will write a letter to the Commissioners recommending Mr. McPaul and Ms. Elton to the Board of Commissioners to vote on at their regularly scheduled meeting on May 14, 2015.

Agenda Item EDC - 4: Montgomery County Planning Commission Walkability Audit

Abington Township was a grant recipient chosen by Montgomery County Planning Commission (MCPC) as a focus area for a transit oriented development audit for MCPC's new Walk Montco project. There was an initial meeting held on April 15th where MCPC talked about the project and next steps moving forward. The next meeting will be in early June and will include local stakeholders that are affected by the walkability in the area. The audit, which will basically be a walk around the Noble station area, along some of the areas that might have impediments to walking and will be scheduled in June.

MCPC suggests that the audit meeting should be at a location in Noble out of convenience to be able to exit the meeting and be in the Noble area for the walking tour. Bruce Goodman offered to research a site for the meeting.

Agenda Item EDC - 5: Old York Rd / Susquehanna Rd

There is a scheduled appraisal on May 1st for the properties located at 1100 and 1102 Old York Rd.

A meeting was held with township representatives, MCPC, and PennDOT to discuss the OYR/Susquehanna project. Next steps after the appraisal are to secure a traffic engineer to conduct a traffic study and to apply for the Multimodal grant.

Eric Goldstein, Executive Director of the King of Prussia District and Graham Copeland, Principal Downtown Dynamics, were welcomed to the EDC. They each gave very informative presentations. Mr. Goldstein's presentation was geared towards the current B.I.D. in King of Prussia. Mr. Copeland was able to provide an overall concept of a B.I.D. and how it is flexible to design and fit specific needs.
