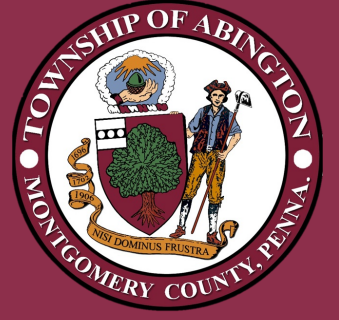

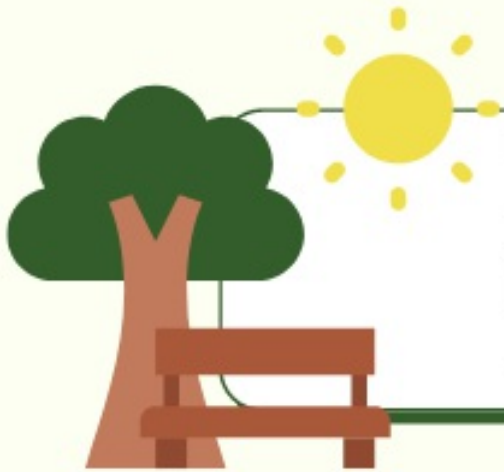
Volunteers Wanted to Serve on Our New Recreation, Parks, and Open Space Advisory Committee!

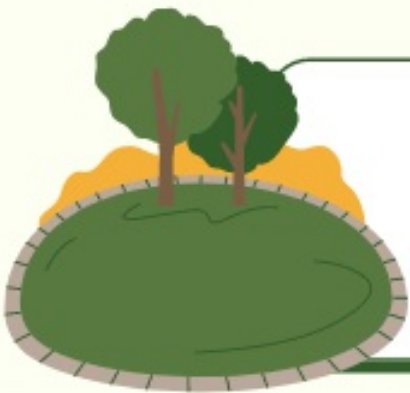
