1) Zoning Compliance Certificate: review by the Zoning Officer of zoning compliance for an existing or proposed use or dimensional change. A Letter will be issued by the Zoning Officer advising of the zoning status and/or detailing potential zoning compliance issues. OR

2) Preliminary Opinion: as provided by the Municipalities Planning Code, Section 916.2 (53 P.S. § 10916.2). A document appropriate for publication, if the Applicant so chooses, will be provided.

The following items need to be submitted with a complete application. An incomplete application will not be reviewed.

- 1. Application Form Completely filled out and signed.
- 2. Application Fee \$150.00 submitted with application Check payable to the Township of Abington.
- **3.** Sketch or Site Plan If the use of the premises is a new use (i.e. vacant building) or a use different or more intense from the previous use, a property sketch or site plan showing the existing and proposed conditions will be required to evaluate parking requirements and other site issues. The plan should include a zoning data table to show the required, existing, and proposed dimensional and bulk requirements under the current zoning district.
- 4. Floor Plans If there is any proposed change in the existing interior tenant arrangement.
- 5. Current Photos Current photos to provide perspective of the existing conditions.
- 6. Additional documentation (as needed) Additional documents may include prior zoning relief granted, access agreements, lease agreements, etc.
- 7. Please attach an addendum if you require additional space to explain your request.

Note: Normal processing time for a full review is approximately 15 days, assuming the submission is complete. If the application is not complete the submission will not be reviewed. The Zoning Compliance Certificate or a preliminary opinion only grants an opinion based on the information provided at the time of request. Separate Use & Occupancy and/or building permits may still be required.
