The applicant is a non-profit organization purchasing a Club liquor license. The only licenses in Abington Township currently being held in safekeeping by the PLCB, which may or may not even be available for purchase, are two Restaurant liquor licenses and a Distributor liquor license. As a non-profit organization with private membership, the applicant could not operate as a restaurant or distributor licensee, which are required to be open to the public under the Pennsylvania Liquor Code. There are three active Club liquor licenses currently located in Abington Township and there is no indication that these licenses are available for purchase. Further, all three of the Club licenses in Abington Township appear to be owned by incorporated units of a national veterans' organization, which can only be transferred to an affiliated organization in accordance with Section 4-461.1 of the Pennsylvania Liquor Code. Therefore, the applicant had to look outside of Abington Township to purchase a Club liquor license.
