PREVIOUS ACTIONS

Board of Commissioners approved New Age Corp. as the lowest responsible bidder for the sandblasting and re-painting of the Crestmont and Penbryn Pools at their March 12, 2015 Board Meeting

RECOMMENDED BOARD ACTION

Motion to approve the re-allocation of \$10,000 from 07-24-800-7531 (Ardsley Center Burn Box Repair), to 07-24-800-7535 (Crestmont/Penbryn Sandblasting). Both accounts are Capital accounts. The projected expenditure to complete this project will be a maximum of \$10,000.

COMMENTS

During the process of sandblasting both pools, 152 linear feet of pool walls developed cracks that needed to be repaired. Additionally, 100 square feet of surface patching was required. Those numbers were higher than expected. The tiling on the baby pool at Crestmont was found to be peeling off. Rather than spend the money on the tiles, the painting contractors will plaster the tiled area and paint the pool up to the coping stones. This will cost considerably less than the cost to retile.

The work done at the Ardsley Community Center on the heaters' burn boxes came in well under budget. All work on the burn boxes is complete.

Amendment to Clear Channel Outdoor Bus Shelter Agreement

PREVIOUS ACTIONS

In January 2011, The Board of Commissioners approved a renewal agreement with Clear Channel Outdoor for the continued maintenance and operation of 25 bus shelter locations. In consideration for the right to locate these facilities in the right-of-way, Clear Channel pays \$1,320 annually to the Township for each location.

These clearances include a criminal history report from the PA State Police, a child abuse history clearance from the Department of Human Services and a fingerprint-based criminal history check submitted via COGENT through the PA State Police and processed by the FBI.

WHEREAS, the Board of Commissioners of the Township of Abington desires to request a Pennsylvania Gaming Local Share Account grant in the amount of \$142,500, representing 75% of the total project cost from the Commonwealth Financing Authority; and

WHEREAS, the Board of Commissioners of the Township of Abington intends to use the grant funds for the purpose of purchasing 1100 and 1102 Old York Road, Abington Township, Montgomery County, Pennsylvania, in order to support the vision of the Old York Road / Susquehanna Road project and Multimodal Grant application (to be submitted on or before July 2015) which will address the alignment of the intersection of Old York Road and Susquehanna Road, enhance traffic flow, and provide better access in turning onto Old York Road; and

WHEREAS, the Board of Commissioners of the Township of Abington desires to designate an official to execute all necessary agreements and documentation related to the grant.
