WHEREAS, Counties, Municipalities and Wastewater Treatment Plant Operators, when not inconsistent with state or federal law, are authorized to oversee and regulate trade, commerce, and the use of public streets, ways, utilities and property within their jurisdictions; and

WHEREAS, the Intergovernmental Cooperation Act (Act of July 12, 1972, P.L. 762, as amended, 53 P.S. §481, et seq.), permits Municipalities, Counties and

Wastewater Treatment Plant Operators to enter into agreements to cooperate in the performance of their respective functions, powers or responsibilities; and

WHEREAS, Counties and Municipalities, as well as the provisions of Pennsylvania's Intergovernmental Cooperation Law, provide for intergovernmental cooperation between and among municipalities in the exercise or performance of their respective governmental functions, powers and responsibilities and authorize joint agreements as may be deemed appropriate for such purposes; and

WHEREAS, The Wissahickon Creek has been designated as impaired under Section 303(d) of the Clean Water Act, and has been assigned a Total Maximum Daily Load (TMDL) per (40 CFR 130.2 and 130.70) and individual wasteload allocations (WLAs) for point sources and load allocations (LAs) for nonpoint sources; and

WHEREAS, The municipalities located in the Wissahickon Creek watershed are obligated under the PADEP's MS4 and NPDES programs to develop and implement a stormwater management plan, and comply with their Sewage Facilities Plan, including TMDL limits, which contain the strategies to meet the municipality's MS4, NPDES and TMDL obligations. It is recognized that the municipal plans will have greater effectiveness and efficiencies if they are coordinated with and incorporated into an Alternative TMDL plan; and

WHEREAS, The EPA's New Long-Term Vision for the 303(d) Program allows for alternative methodologies to the proposed TMDL that incorporates broader, more comprehensive and adaptive management strategies that are tailored to this watershed's specific circumstances. The Counties, Municipalities and Wastewater Treatment Operators have considered that developing an Alternative TMDL Plan to satisfy the overall intent of the proposed EPA TMDL pollutant reductions to improve the biological integrity of the watershed is a justified and necessary action; and

WHEREAS, the impacted Municipalities in Montgomery and Philadelphia Counties and the Wastewater Treatment Plant Operators recognize that watersheds cross municipal boundaries and a coordinated planning effort is to the benefit of all Municipalities and Counties and that it is in the best interest of their property owners to cooperate in the development of an Alternative to the proposed EPA TMDL through participation in this collaborative effort.

WHEREAS, the Municipalities and Wastewater Treatment Plant Operators recognize that the coordination of services and sharing of information would enable each Municipality to minimize the costs of the administration and implementation of an Alternative Plan; and

NOW THEREFORE, BE IT RESOLVED as follows:

The Township of Abington desires to authorize its appropriate officers to enter into a collaborative partnership with other Wissahickon Creek municipalities to advance the development of an alternative plan to the proposed EPA TMDL with terms to be formalized in a future Inter-municipal Agreement.

BE IT FURTHER RESOLVED, that this collaboration strategy by and between Township of Abington, (which includes our Wastewater Treatment Plant), a Township of the First Class, and a municipal corporation organized under the laws of Pennsylvania with its municipal offices located in Abington Township, Montgomery County, Pennsylvania, and various other local participating Boroughs and Townships and Wastewater Treatment Plant Operators within the Commonwealth of Pennsylvania, to represent the municipal interests in the creation of a future Alternative Plan to the proposed EPA TMDL for the Wissahickon Watershed.

WHEREAS, the Board of Commissioners of the Township of Abington has determined that Chapter 142 – "Stormwater Management," should be amended by the repeal of the existing provisions and replaced with the provisions attached hereto, incorporated herein and labeled Exhibit "A" for the health, safety, morals, general welfare, cleanliness, beauty, convenience and comfort of the Township and the inhabitants thereof.

NOW, THEREFORE, the Board of Commissioners of the Township of Abington does hereby ENACT and ORDAIN as follows:

- 1. Chapter 142 "Stormwater Management," is amended to repeal the existing provisions in their entirety and replacing them with as reflected in Exhibit "A" attached hereto.
- 2. All other ordinances, portions of ordinances, or any section of the Code inconsistent with this Ordinance are hereby repealed.

Ordinance No. 2107 - Retirement Pension Benefit

Commissioner Bowman made a MOTION, seconded by Commissioner Hecker to adopt Ordinance No. 2107 amending the Non-Uniform Pension Plan to include an Act 44 Deferred Retirement Option (DROP).

Commissioner Luker asked for any comments from Commissioners or staff. There were none.

Commissioner Luker asked for any public comments.

Lora Lehmann, 1431 Bryant Lane, asked has an analysis been made as to whether the DROP program is revenue-neutral.

Manager LeFevre replied State Legislature enacted Act 44 in which they put strict limitations on the DROP benefits going forward. The motion of proposed DROP benefit falls under Act 44. Also, employees are increasing their pension contribution to offset any potential costs associated with the DROP program and the Township's costs are fully covered by employees' contributions, so there is no financial exposure to the Township whatsoever.

TOWNSHIP OF ABINGTON MONTGOMERY COUNTY, PENNSYLVANIA ORDINANCE NO. 2107

AN ORDINANCE OF THE TOWNSHIP OF ABINGTON, MONTGOMERY COUNTY, PENNSYLVANIA AMENDING THE NON-UNIFORMED PENSION PLAN TO INCLUDE AN ACT 44 RETIREMENT PROGRAM

WHEREAS, the Township of Abington did, by Resolution 14-032 restate the Non-Uniformed Pension Plan; and

WHEREAS, on September 18, 2009, Act 44 was approved by the Pennsylvania Legislature amending Title 53 as it relates to Municipal Non-Uniformed Pension Plans; and

WHEREAS, the Township determined it is desirable and beneficial to establish an Act 44 Retirement Program for its Non-Uniformed employees who meet certain eligibility requirements; and,

WHEREAS, to implement the terms of the Act 44 Retirement Program, it is necessary for the Township to adopt an Ordinance amending its Non-Uniformed Pension Plan; and

NOW, THEREFORE, BE IT ORDAINED THAT:

The Township of Abington hereby adopts the following Act 44 Program provisions which are incorporated into and made a part of the Non-Uniformed Pension Plan of the Township of Abington. Resolution 14-032 is AMENDED to add a new section establishing and implementing an Act 44 Retirement Program:

- 1. Title. This Section shall be known as the "Township of Abington Non-Uniformed Act 44 Retirement Program."
- 2. Definitions. When used in this Section, the below words shall have the meaning indicated.

"Township" - Township of Abington, Montgomery County, Pennsylvania.

"ACT 44 PROGRAM" - The ACT 44 DEFERRED RETIREMENT OPTION PROGRAM of the Township of Abington.

"ACT 44 PROGRAM Account" – Separate ledger account created to accept ACT 44 PROGRAM participants' monthly pension benefit while an ACT 44 PROGRAM participant, as well as any interest thereon.

"Fund" or "Plan" - the Non-Uniformed Pension Plan.

"Participant" – a Non-Uniformed Employee who meets the eligibility for and has executed the proper documents for participation in ACT 44 PROGRAM and has had such application approved by the Township.

"Non-Uniformed Employees" - Non-Uniformed Employees of the Township of Abington.

3. Eligibility. Eligibility for the ACT 44 PROGRAM shall be determined as follows:

- A. Non-Uniformed Employees who have not retired prior to the implementation of the ACT 44 PROGRAM may enter into the ACT 44 PROGRAM on the first day of the month after reaching his/her Normal Retirement Date but not prior to the Effective Date of the Act 44 PROGRAM.
- **4. Written Election.** Eligible Employees who wish to be Participants in the ACT 44 PROGRAM must signify that intention in writing as follows:
 - A. A Non-Uniformed Employee electing to participate in the ACT 44 PROGRAM must complete and execute an "ACT 44 PROGRAM Participation Election Form" prepared by the TOWNSHIP, which shall evidence the participant's election to participate in the ACT 44 PROGRAM. The form must be signed by the Non-Uniformed Employee and be notarized and submitted prior to the date on which the participant wishes ACT 44 PROGRAM participation to commence. The ACT 44 PROGRAM Participation Election Form shall include an irrevocable notice to the Township, by the Non-Uniformed Employee participant, that the Non-Uniformed Employee shall resign from employment with the Non-Uniformed Department effective on a specific date (the "resignation date") that is no later than Township twenty-four (24) months from the effective date of the ACT 44 PROGRAM Election Form. A Non-Uniformed Employee shall cease to work as and may no longer be employed as a Non-Uniformed Employee on the employee's resignation date, unless the Township properly terminates or honorably discharges the employee prior to the resignation date. A participant may resign from employment while in ACT 44 PROGRAM status, which shall terminate his/her participation in the ACT 44 PROGRAM.
 - B. In addition to the above information, the ACT 44 PROGRAM Participation Election Form shall also advise the employee of the following: (1) an explanation of the Participant's rights and obligations while in ACT 44 PROGRAM; (2) that, as a condition of ACT 44 PROGRAM participation, the Participant foregoes active participation in the Non-Uniformed Pension Plan and foregoes any recalculation of pension benefits to include salary increases occurring after ACT 44 PROGRAM participation commences; and (3) that the ACT 44 PROGRAM Participant's service while in ACT 44 PROGRAM will not count as pension service nor will it entitle a participant to any service increment benefits to which the Participant was not entitled prior to commencing ACT 44 PROGRAM participation. An ACT 44 PROGRAM Participant must also complete any and all retirement documents required by the Non-Uniformed Pension Plan Administrator, and such documents must be filed and presented to the TOWNSHIP for approval of retirement and payment of pension. Once an ACT 44 PROGRAM Participation Election Form has been approved by the Township, it is irrevocable. Likewise, once an ACT 44 PROGRAM Participant enters the ACT 44 PROGRAM, the Participant may not subsequently leave and then re-enter the ACT 44 PROGRAM, even if the employee separates from employment and subsequently begins employment with the Township again.
- 5. Benefit Calculation. For all Pension Plan purposes, continuous service of a Non-Uniformed Employee participating in the ACT 44 PROGRAM shall remain as it existed on the effective date of commencement of participation in the ACT 44 PROGRAM.

Service thereafter shall not be recognized or used for the calculation or determination of any benefits payable by the Township Non-Uniformed Pension Plan. The average monthly compensation of the Non-Uniformed Employee for pension calculation purposes shall remain, as it existed on the effective date of commencement of participation in the ACT 44 PROGRAM. Earnings or increases in earnings thereafter shall not be recognized or used for the calculation or determination of any benefits payable by the Pension Plan. The pension benefit payable to the participants shall increase only as a result of Cost of Living Adjustments in effect on the effective date of the participant's participation in the ACT 44 PROGRAM or by applicable cost of living adjustments granted thereafter.

- 6. Accumulation of the ACT 44 PROGRAM Account. The monthly retirement benefits that would have been payable had the Non-Uniformed Employee elected to cease employment and receive a normal retirement benefit, shall, upon the Non-Uniformed Employee commencing participation in ACT 44 PROGRAM, accumulate to the benefit of that Employee and be accounted for on that Non-Uniformed Employee's ACT 44 PROGRAM Account. Participants shall not have the option of self-directed investment of their individual ACT 44 PROGRAM Account while in the ACT 44 PROGRAM. Instead, the monies shall be invested in a fund to be identified and selected solely by the Township in accordance with applicable law so as to generate a rate of return of no less than zero percent (0%) and no more than four and a half percent (4.5%).
- 7. Accrual of Non-Pension Benefits. After a Non-Uniformed Employee elects to participate in the ACT 44 PROGRAM, all other contractual benefits shall continue to accrue with the exception of those provisions relating to the Non-Uniformed Pension Plan.
- **8.** Payout. Upon separation from employment, the ACT 44 PROGRAM payout options available to the ACT 44 PROGRAM Participant shall be as follows:
 - A. The balance of the ACT 44 PROGRAM Participant's account, less withholding taxes, if any, remitted to the Internal Revenue Service, shall be paid to the Participant or the Participant's surviving beneficiary.
 - B. The balance of the ACT 44 PROGRAM Participant's account shall be paid directly to the custodian of an eligible retirement plan as defined by Internal Revenue Code Section 402(c)(8)(b), or in the case of an eligible rollover distribution to the surviving spouse of a deceased ACT 44 PROGRAM Participant, an eligible retirement plan that is an individual retirement account or an individual retirement annuity as defined by Internal Revenue Code Section 402(c)(9).
 - C. If the ACT 44 PROGRAM Participant or beneficiary fails to make an election within sixty days (60) following the date of termination of ACT 44 PROGRAM participation, then the Chief Administrative Employee of the Pension Plan shall implement section (8)(A.) above.
- 9. Disability During ACT 44 PROGRAM. An ACT 44 PROGRAM Participant who becomes permanently disabled during the DROP period and retires from service will revert to the normal age and service pension pursuant to the Plan, and will thereafter directly receive pension payments that were being deposited into the ACT 44 PROGRAM

Participant's DROP Account. The Participant will then have access to distributions from his or her DROP Account in any manner permitted by law. If a Participant becomes temporarily disabled during his or her participation in the DROP Program, the time period while on disability counts toward the twenty-four (24) month participation limit. Participant shall receive disability pay in the same amount as disabled employees who are not participating in the DROP Program. In no event shall a Participant on temporary disability have the ability to draw from the DROP Account. However, notwithstanding any other provision in this Paragraph, if a Participant is disabled and has not returned to work as of the date of his or her required resignation, then such resignation shall take precedence over all other provisions herein and said Participant shall immediately resign. In addition, if a Participant's disability becomes permanent during the DROP period, he or she shall be discharged from employment immediately, regardless of where in the DROP period his or her service stands. A Participant participating in the DROP program who becomes permanently disabled as the result of a work-related condition shall not be eligible to receive a disability pension benefit. Nothing hereunder shall be construed as conferring any legal rights upon any employee or other person to a continuation of employment nor shall participation in the DROP Program in any way supercede or limit the right of the Township to discharge an employee based upon an inability to perform his or her full duties.

- 10. Death. If an ACT 44 PROGRAM Participant dies, the Participant's eligibility for ACT 44 PROGRAM shall terminate upon the date of death. In such case, if the ACT 44 PROGRAM account balances have not yet been paid out, the Participant's legal beneficiary shall have the same rights and options as the Participant to withdraw/roll over the account balance.
- 11. Forfeiture of Benefits. Notwithstanding a Non-Uniformed Employee's status as an ACT 44 PROGRAM Participant, a current or former Participant who is convicted or pleads guilty to engaging in criminal misconduct which constitutes a "crime related to public office or public employment," as that phrase is defined in Pennsylvania's Pension Forfeiture Act, 43 P.S. §§ 1311-1314, shall forfeit his right to receive a pension, including any amounts currently deposited in the ACT 44 PROGRAM Account. In such a case, the Participant shall only be entitled to receive the contributions, if any, made by the Participant to the Non-Uniformed Pension Fund, without interest.
- 12. Cost of Management for ACT 44 PROGRAM. The Non-Uniformed Employees and the Township agree that any costs or fees associated with the management of the ACT 44. PROGRAM accounts shall be paid directly and solely by the Participant and not by the Township or the Pension Fund.
- 13. Amendment. Any amendments to this ACT 44 PROGRAM Ordinance shall be consistent with the provisions covering Individual Retirement option plans set forth in any applicable collective bargaining agreement and shall be binding upon all future ACT 44 PROGRAM Participants and upon all ACT 44 PROGRAM Participants who have balances in their Individual Retirement option accounts. The ACT 44 PROGRAM may only be amended by a written instrument, not by any oral agreement or past practice.
- 14. Construal of Provisions. A Non-Uniformed Employee's election to participate in the ACT 44 PROGRAM shall in no way be construed as a limitation on the Township's right to

- suspend or to terminate a Non-Uniformed Employee for just cause or to grant the Non-Uniformed Employee an honorable discharge based upon a physical or mental inability to perform his or her duties.
- 15. Severability. The provisions of the ACT 44 PROGRAM shall be severable: and if any of its provisions shall be held to be unconstitutional or illegal, the validity of any of the remaining provisions of the ACT 44 PROGRAM shall not be affected thereby. It is hereby expressly declared as the intent of the Township that the ACT 44 PROGRAM would have been adopted had such unconstitutional or illegal provision or provisions not been included herein.
- 16. Effective Date. The Effective Date of the ACT 44 PROGRAM shall be January 1, 2016.
- 17. All elected and appointed officials of Township are authorized to take all action necessary to ensure the implementation and effect the purpose hereof.
- 18. Any and all Ordinances and/or Resolutions, or parts thereof, conflicting herewith are repealed insofar as the matters herein are affected.
- 19. The provisions of this Ordinance are severable, and if any clause, sentence, subsection or section hereof shall be adjudged by any court of competent jurisdiction to be illegal, invalid or unconstitutional, such judgment or decision shall not affect, impair or invalidate the remainder but shall be confined in its operation and application to the clause, sentence, subsection or section rendered. It is hereby declared the intent of the Township Council that this ordinance would have been adopted if such illegal, invalid, or unconstitutional clause, sentence, subsection, or section had not been included therein.
- 20. This is effective immediately upon enactment according to law, and shall remain in effect hereafter until revised, amended, or revoked by action of the Township Council.

Not long before the December 16th meeting was the Army Corp of Engineers proposing three of their nine Cheltenham flood-mitigation basins to be on Abington Township property. Public comment period has been extended again to the February 22, 2016 deadline.

Commissioner Rothman thanked his colleagues and Township for being very welcoming during his learning process. He wished a "Happy Birthday" to officials of the Abington Free Library.

Also, his neighbor had a baby this morning and he welcomed Tessa Goldstein to Abington.

Commissioner Myers congratulated the Abington Free Library on their 50th Birthday.
