COMMENTS

- 1.) The project will include an interconnect system similar to the ones we currently have on York Road and on Huntingdon Pike. It will also include new traffic signal poles where needed. All new wiring, signal heads, and anything else necessary to get the signal equipment up to current standards.
- 2.) The Easton Road Corridor signals are in need of an upgrade as the equipment is now in need of replacement. This project will bring us close to 70% of our intersections having been upgraded in the last 6 years.
- 3.) The match will be 20% of the cost for the project. It is anticipated that the match will be approximately \$189,000.00.
- 4.) We anticipate that if we are awarded the grant, that the project start up would take another year to begin.

Project Name: Easton Road Traffic Signal System Project

Project Abstract: In the space below, provide a brief project abstract that accurately and concisely summarizes the candidate project or program.

The Township has identified the potential for expanding the existing traffic signal system which is located along Susquehanna Road to include eight (8) additional intersections along Easton Road. The Easton Road corridor is an arterial within Abington Township and serves as an alternate to Route 611, which is a major arterial. Easton Road is limited to future roadway improvements due to available right-of-way.

In order to address the future traffic demands on this corridor, as well as provide for incident management, a traffic signal system consistent with current Township system is necessary to provide the best management and operation of the existing traffic signals along the corridor which include:

- 1. Easton Road and Hamilton Avenue
- 2. Easton Road and Woodland Road
- 3. Easton Road and Bradfield Road
- 4. Easton Road and Susquehanna Road (S.R. 2017)
- 5. Easton Road and Edge Hill Road
- 6. Easton Road and Castlewood Road\Copper Beach Elementary
- 7. Easton Road and Jenkintown Road
- 8. Easton Road and Keswick Avenue
- 9. Easton Road and Mt. Carmel Avenue

The project intersections would be connected with the existing Eagle Marks system located along Susquehanna Road. The Susquehanna Road system is currently monitored at a central computer with a dial connection to the master controller located at the intersection of Susquehanna Road and Easton Road. The existing system would be expanded to include the Easton Road intersections and would communicate via spread spectrum radio. Additionally, minor traffic signal improvements at the intersections are included in the project, including traffic signal controller upgrades, battery back-up, video detection, and pedestrian signal upgrades.

The Township has identified the potential for the expansion of the existing traffic signal system along Susquehanna Road. The Township currently maintains and operates an Eagle Marx system for the Susquehanna Road corridor from Bradfield Road to Edge Hill Road. The system it accessible form the Township's central computer through a dial connection with the master controller at the intersection of Susquehanna Road and Easton Road. The existing system would be expanded to include an additional eight (8) intersections along the Easton Road corridor. Additionally, Easton Road serves as an alternate route for the heavily traveled Old York Road (S.R. 0611) corridor. A Location Map has been included in **Appendix A**.

The Township has evaluated the corridor through various studies throughout the years, including comprehensive plans. The Township has also identified the Easton Road corridor as a high potential for redevelopment of the existing commercial properties. Several recent land developments have been submitted for this corridor. The existing roadway network is limited for expansion due to existing right-of-way and location of buildings.

In order to address the future traffic demands on this corridor, as well as provide for incident management, the expansion of the existing traffic signal system is necessary to provide the best management and operation of the additional eight (8) existing traffic signals along the Easton Road corridor. The improvements to the traffic signals are anticipated to include, but not be limited to, the following:

- Expansion of the existing Traffic Signal System to include eight (8) additional intersections along Easton Road. The existing system software would be updated to include the additional intersections. The additional intersections would communicate with the master controller located at the intersection of Susquehanna Road and Easton Road through the use of spread spectrum radio. The Township currently has systems operating with spread spectrum radio and the Township has experience in maintaining these systems. For example the Huntingdon Pike Corridor operates with a spread spectrum radio system.
- Improvements to the intersections will be provided under this project for connection to the existing signal system, as well as, minor signal improvements to enhance the operation. The proposed signal improvements have been identified in **Attachment B** which has been included.

The installation of an adaptive signal system was evaluated for this project; however, it was determined that the traffic signal system with a central computer was the more appropriate design approach as well as more cost effective. The current intersections are not interconnected nor connected to a central monitoring system. Creating the traffic signal system will provide a significant benefit to the signal operation. This system should be implemented and monitored for its effectiveness prior to evaluating the need for an adaptive signal system.

2. The project will include an interconnect system similar to the ones we currently have on York Road and on Huntingdon Pike. The RFP's include Design, Meetings, Bid Specs, etc.

3. This RFP is for the Engineering and Design Phase of the project. We will go out for another RFP for the Inspection and Construction phase of the project. We anticipate our share of the match to be approximately \$189,000.00.

4. The grant is for close to \$1,000,000.00.



Ordinance No. 2133 Amendment to the Human Relations Commission Ordinance

PREVIOUS ACTIONS

April 12, 2012 – The Board of Commissioners established the Township Human Relations Ordinance by Ordinance No. 2029.

ORDINANCE NO. $\frac{2/35}{5}$ AN ORDINANCE OF THE TOWNSHIP OF ABINGTON, MONTGOMERY COUNTY, PENNSYLVANIA, AMENDING CHAPTER 137 – "SNOW AND ICE REMOVAL," AT SECTION 4 – "VIOLATIONS AND PENALTIES"

WHEREAS, Abington Township is a Township of the First Class, organized and operating in accordance with the laws of the Commonwealth of Pennsylvania, and

WHEREAS, pursuant to the First Class Township Code of the Commonwealth of Pennsylvania, the Board of Commissioners of Abington Township ("Board of Commissioners") has the authority to enact and amend provisions of the Abington Township Code (the "Code") at any time it deems proper; and

WHEREAS, the Board of Commissioners has determined that portions of Chapter 137 – "Snow and Ice Removal," at Section 4 – "Violations and Penalties" of the Code should be amended for the health, welfare, and safety of the residents of Abington Township.

NOW, THEREFORE, be it and it is hereby resolved as follows:

1. The Board of Commissioners hereby amends Chapter 137 – "Snow and Ice Removal," at Section 4 – "Violations and Penalties," to read as follows, with the underlined text indicating the revised provisions of the Code and the stricken text indicating the removed provisions of the Code: "Any person who shall violate any of the provisions of this chapter or who shall fail to comply with the conditions or requirements in accordance with the provisions of this chapter shall, upon conviction thereof, be liable to pay a fine of <u>up to \$1,000 per offense</u>. For each subsequent offense committed within the same calendar year, the amount of the fine shall increase by \$20 per offense. The amount of the fines set forth herein may be reset from time to time by resolution of the Board of Commissioners. A new and separate offense shall be deemed to have been committed for each day that said violation exists. All fines imposed by this chapter are recoverable by summary proceedings before any District Justice in the Township of Abington, and, upon recovery thereof, all such fines shall be paid into the treasury of the township. In

default of the payment of any fine imposed by any District Justice under the provisions of this chapter, the person so offending may be committed to the jail for a period of one day.

- All other ordinances, portions of ordinances, or any section of the Code inconsistent with this Ordinance, are hereby repealed.
- 3. This Ordinance shall become effective five (5) days after enactment.

SETTING THE COMPENSATION OF THE ABINGTON TOWNSHIP TAX COLLECTOR FOR THE PERIOD 2018 THROUGH 2021

\$22,000.00	Total Township Compensation

BE IT FURTHER RESOLVED, that the Township will provide the computer and software and permit the Tax Collector to use the existing furnished office space in the Township Building, or a space of equal size, for a rental fee of \$100 per month.
