A motion to approve the amended minutes of January, 2017 was made by Teresa Scroggins seconded by Elaine Shay.

#### TREASURER'S REPORT:

- 2016 Budget needs to be changed to accommodate the changes to the salary line
- Tom Tyler made a motion to approve proposed budget changes for 2016; seconded by Brian Mays. Motion passed.
- Elaine Shay made a motion to approve the revised December, 2016 Treasurer's Report as presented at the Feb, 2017 meeting; seconded by Garrett Page. Motion passed.
- Thanks to Kevin Barron, Township Finance Director, for his patience and guidance to resolve budget misalignment.
- January, 2017 Treasurer's report reviewed and filed for audit.
- November, 2015 Annual Appeal Funds discussion about where to invest the roughly \$60,000 into Special Income.
   Teresa Scroggins made a motion to deposit the \$60,602 from the November, 2015 Annual Appeal into the BB&T Savings Account (#5 in Special Income), account # 1390002667491. Motion seconded by Elaine Shay. Motion passed.
- Motion by Tom Tyler to destroy the 2009 accounts payable, voided checks, meeting room invoices, and time sheets (based on 7 year retention schedule). Garrett Paige seconded. Motion passed.

## **ADULT LITERACY: Presentation**

- Elizabeth Sperling came to discuss the financial outlook with the Board
- New tutor training in March, 33 people signed up (double the normal size)
- There are 4 grant applications out right now; program is waiting to find out if grants have been awarded.
- EL Civics Grant:
  - 1. No new changes until December, 2018
  - 2. PA Labor and Industry operates CareerLinks and all grantees will subcontract through it
  - 3. The program is more of a "job readiness" program; we do not have the resources to do job training
- If the funding is gone as of July, 2017, what will be the plan? It is likely the \$33,000 funding will be gone. That is the largest funding source. Elizabeth shared a list of 9 possible paths forward for a way to redefine the program and try to carry it forward.
- This issue needs to be addressed immediately; Nancy suggested a committee be formed to carve a path forward if all federal funding disappears. Volunteers from the board are going to meet prior to the March meeting to discuss.
- Elizabeth will meet with her volunteers and talk about the top priorities for the program in the future.
