### **ORDINANCE NO. 2138**

AN ORDINANCE AMENDING CHAPTER 156 – "VEHICLES AND TRAFFIC,"

ARTICLE II – "TRAFFIC REGULATIONS"

SECTION 14 – "STOP INTERSECTIONS"

ARTICLE III – "PARKING REGULATIONS"

SECTION 25 – "PARKING PROHIBITED AT ALL TIMES; NO PARKING BETWEEN SIGNS; NO PARKING HERE TO CORNER; PARKING PROHIBITED EXCEPT CERTAIN HOURS; NO STOPPING OR STANDING"

WHEREAS, the Township of Abington is a Township of the First Class, duly organized and existing pursuant to the applicable laws of the Commonwealth of Pennsylvania; and

WHEREAS, pursuant to section 1502.44 of the First Class Township Code of the Commonwealth of Pennsylvania, 53 P.S. §56544, the Board of Commissioners has the authority to enact and amend provisions of the Abington Township Code ("Code") at any time it deems necessary for the health, safety, morals, general welfare, cleanliness, beauty, convenience and comfort of the Township and the inhabitants thereof; and

WHEREAS, pursuant to section 1502.10 of the First Class Township Code of the Commonwealth of Pennsylvania, 53 P.S. §56510, the Board of Commissioners has the authority to take all needful means for securing the safety of persons or property within the Township; and

WHEREAS, pursuant to section 1502.49 of the First Class Township Code of the Commonwealth of Pennsylvania, 53 P.S. §56549, the Board of Commissioners has the authority to regulate parking; and

WHEREAS, the Board of Commissioners of the Township of Abington has determined that Chapter 156 – "Vehicles and Traffic," Article II – "Traffic Regulations," Section 14 "Stop Intersections" and Article III – "Parking Regulations," and Section 25 "Parking Prohibited At

All Times; No Parking Between Signs; No Parking Here To Corner; Parking Prohibited Except Certain Hours; No Stopping Or Standing" should be amended for the health, safety, morals, general welfare, cleanliness, beauty, convenience and comfort of the Township and the inhabitants thereof.

**NOW, THEREFORE**, the Board of Commissioners of the Township of Abington does hereby **ENACT** and **ORDAIN** as follows:

Chapter 156 – "Vehicles and Traffic," Article II – "Traffic Regulations," Section 14 –
 "Stop Intersections," shall be amended to <u>add</u> the following restrictions:

Rodman Avenue	Eastbound and westbound	Upland Avenue		

2. Chapter 156 – "Vehicles and Traffic," Article III, "Parking Regulations," Section 25 – "Parking Prohibited At All Times; No Parking Between Signs; No Parking Here To Corner; Parking Prohibited Except Certain Hours," shall be amended to <u>add</u> the following restrictions:

3. All other ordinances, portions of ordinances, or any section of the Code inconsistent with this Ordinance are hereby repealed.

**MINUTES:** Commissioner Schreiber made a MOTION, seconded by Commissioner Spiegelman to approve the minutes of the Public Safety Committee Meeting of March 1, 2017.

MOTION was ADOPTED 5-0.

### Police Department Report:

Chief Livingood reported that previously, we spoke about steps that have been taken in response to attacks and incidents occurring at cemeteries and religious institutions and he provided a report on an update on active shooter training, security assessments and training exercises. Over the last few years, a total of 84 trainings and/or assessments were completed and accomplished in addition to normal routine duties.

On January 20, 2017, a press release was posted about five men who were arrested and charged with a series of high-end burglaries in Abington as well as other jurisdictions. One of these burglaries occurred on August 28, 2015 at a residence on Jericho Road in Abington and one of the five men arrested has been identified as the "fence" of stolen property. The Police Task Force issued a series of search warrants including three of them on Jewelers Row in Philadelphia. Approximately 115,000 pieces of jewelry worth millions of dollars and a press release by Montgomery County District Attorney was previously distributed regarding this incident.

Commissioner Schreiber acknowledged Rich Garrett, Second Alarmers, who was present to answer any questions by the Board.
