#### **Datacenter Upgrade**

#### **PREVIOUS ACTIONS**

- The 2017 capital budget provides funding for the network server as approved by the Board of Commissioners.
- The Board approved a motion to advertise the bid for the Datacenter Upgrade on March 9, 2017.
- The bid was duly advertised with proposals from two (2) prospective bidders.

#### RECOMMENDED BOARD ACTION

 Motion authorizing the proper Township officials to contract with MJM Systems, Inc., for a five (5) year term in an amount not to exceed \$160,000.00 for the Datacenter Upgrade. Funds will be drawn from Capital Accounts reserved for this purpose.

#### COMMENTS

- The Township received two bids for the Datacenter Upgrade. Staff recommends acceptance of the datacenter bid proposal from MJM systems for a five (5) year term of \$160,000.00.
- Accepting this bid will replace all hardware in our datacenter and all VMware software. It will also provide the Township with a new disk-todisk backup system fully integrated with VMware, as well as hardware redundancy by placing additional servers at Public Works.
- The cost covers 5 years of licensing of hardware support, with an option to extend past 5 years. The current data center is almost 7 years old and we hope to get the same lifespan out of this new one.

# ABINGTON TOWNSHIP RESOLUTION NO. 2017-017

# A RESOLUTION OF ABINGTON TOWNSHIP, COUNTY OF MONTGOMERY, COMMONWEALTH OF PENNSYLVANIA, IN SUPPORT OF A CITIZEN'S COMMISSION FOR LEGISLATIVE AND CONGRESSIONAL REDISTRICTING

WHEREAS, the citizens of the Township of Abington and the Commonwealth of Pennsylvania deserve a fair, fully transparent, impartial and depoliticized process of the decennial drawing of state legislature and congressional districts of near equal population; and

**WHEREAS**, legislative and congressional redistricting has often resulted in the gerrymandering of districts to favor one political party or the other; and

WHEREAS, such gerrymandering of legislative and congressional districts has worked at times to the detriment of our representative democracy by impeding action on critical issues of importance to the people; and

WHEREAS, the creation of a truly independent citizens redistricting commission devoid of political motivation or partisanship will help to ensure a fair and accurate legislative and congressional redistricting process that respects political subdivisions, will prohibit districts from being drawn to favor or discriminate against a political party or candidate, will promote transparency, the use of impartial and sound methodology when setting district boundaries, and allow for public input, and will fully comply with the constitutional requirement that "no county, city, incorporated town, borough, township or ward" be divided "unless absolutely necessary," and

WHEREAS, recent legislation has been introduced in the current legislative session to amend the Pennsylvania Constitution to reform the decennial legislative and congressional redistricting process with the intent of using fairness and sound methodology in a non-partisan fashion.

**NOW, THEREFORE, BE IT RESOLVED** that Abington Township does hereby support legislative efforts to secure expeditious action to make a constitutional amendment that would, among other reforms, assign the decennial task of both

legislative and congressional redistricting to an independent citizens redistricting commission; and

**BE IT FURTHER RESOLVED** that we call upon all those elected officials in the Commonwealth of Pennsylvania who represent the citizens of Abington Township (see list) to publicly announce their support of and commitment to work towards passage of such legislative efforts, and that a copy of this resolution be delivered to each of them:

**MINUTES:** Commissioner Spiegelman made a MOTION, seconded by Commissioner Kalinoski to approve the minutes of the March 1, 2017 Public Affairs Committee Meeting.

MOTION was ADOPTED 4-0.

<u>Environmental Advisory Council Report – Power Presentation on Accomplishments and STAR Communities:</u>

Jennifer Sherwood, Chairperson of the EAC, provided an annual report of 2016's objectives, goals and enhancing sustainability The EAC's volunteers achieved a three-star rating out of five from Star Communities, and since Penn State has become a Star-affiliate, we will be working with them on future plans. She thanked the Board of Commissioners for their help as well as community partners for their assistance in their 3-Star Achievement. Future plans to improve sustainability include the Master Bike Plan, Walk and Park Train Abington project, Shop Local Program and Go Green Rewards Card program. The EAC helps the Township meet its water quality requirements as part of the Clean Water Act and MS4 requirements and Rain Barrel Town. We also partner with stormwater management projects in the Township as well as hold Clean-Up Events.

2017 Earth Day Cleanups have been scheduled and we provide education to the public. In 2015, we partnered with Audubon Society to become an Audubon Bird Town. 2017 upcoming events have been scheduled and posted on <a href="www.eac-abington.org">www.eac-abington.org</a> as well as goals and how to help the EAC. Nominations for the Montgomery Award are due by April 30<sup>th</sup>.

Commissioner Markman thanked Ms. Sherwood and the members of the EAC for all the positive work they do for the Township and we are lucky to have you.

#### Parks and Recreation Report:

Parks and Recreation Director, Mr. Andy Oles, reported that the Township's Annual Easter Egg Hunt will be held on Saturday, April 8th at Alverthorpe Park at 10 a.m. Last day for pool discount is Monday, April 17<sup>th</sup>. Alverthorpe Spring Yard Sale will be held on Saturday, April 29<sup>th</sup> with a rain date on April 30<sup>th</sup>.

Also, upcoming in May will be a trip to Annapolis, MD. Activities guide should be arriving at resident's homes this week and they are also located at the Post Office, Township building, Ardsley Community Center, Alverthorpe Park, the Parks Main Office and the Library. He encouraged everyone to get their account setup for online registration for Township programs and pool membership.

<u>Bid Award – Community Facility at Crestmont Park</u> (Bids were opened on Tuesday, February 4<sup>th</sup>)

Commissioner Spiegelman made a MOTION, seconded by Commissioner Kalinoski to accept the lowest Responsible Bidder and enter into a contract with L.J. Paolella Construction, Inc. in the amount of \$1,545,571.00 to construct a new community facility at Crestmont Park.

Commissioner Spiegelman called on Community Development Director, Mr. Van Strother.

Mr. Strother explained that three bids were received and the lowest bidder is listed in the motion and he recommends award to that contractor.

Commissioner Spiegelman asked for any comments from Commissioners or staff.

Commissioner Kline asked about items deducted from the project in terms of bids received.

Mr. Strother replied deduct alternates were listed in the bid submitted and two of the deduct bids were reducing field stone on the exterior and interior of the building for an amount of \$44,000. There was an alternate bid to reduce the fire alarm pull stations since it is a one-story building and code does not require it and that brought cost down to amount listed on the agenda.

Commissioner Kline clarified that the basement was also eliminated and it is now a slab on grade. Is that correct?

Mr. Strother replied that is correct.

Commissioner Spiegelman asked for any public comments. There were none.

MOTION was ADOPTED 4-0.

### Funding of the Community Facility at Crestmont Park

Commissioner Spiegelman made a MOTION, seconded by Commissioner Kalinoski to authorize the use of funds from BB&T Account Number 1390000740639 in the amount of \$119,027.62 (as of 01/31/2017) to fund the construction of the new community facility at Crestmont Park. This account was established on August 31, 1990 for affordable housing purposes that has been replaced by funding from HUD and DCED. (The intent is to close the account and apply all funds to this project).

Commissioner Spiegelman asked for any comments from Commissioners or staff. There were none.

Commissioner Spiegelman asked for any public comments. There were none.

MOTION was ADOPTED 4-0.

#### Grant Award Acceptance for TAP Grant Trail Development

Commissioner Spiegelman made a MOTION, seconded by Commissioner Kalinoski to accept the Transportation Alternatives Program (TAP) grant from PA Department of Transportation in the amount of \$450,000.00. The grant will support the construction costs for phase one of the bicycle plan.

Commissioner Spiegelman asked for any comments from Commissioners or staff.

Commissioner Kline commended Assistant Township Manager Wehmeyer for her work on the grant and Simone Collins who was also involved in grant application as well as the Master Bike Plan Committee, who worked on putting this plan together. This will be 3.26 miles in the western part of the Township connecting to Ardsley and Crestmont Train Stations.

Commissioner Spiegelman asked for any public comments. There were none.

MOTION was ADOPTED 4-0.

<u>Grant Award Acceptance for DCNR Grant for Design and Engineering for Bike Lane Implementation</u>

Commissioner Kalinoski clarified that the entire Master Bike Plan was funded by grants. Is that correct?

Assistant Township Manager Wehmeyer replied construction, design and engineering costs were funded by grants for Phase I.

<u>Proposal Acceptance for Professional Services – Abington Transportation Alternatives</u> <u>Program (TAP) Trail</u>

Commissioner Spiegelman made a MOTION, seconded by Commissioner Kalinoski to accept the proposal from the team of Simone Collins Landscape Architecture to prepare the construction documents through the Transportation Alternatives Program (TAP) grant for the Abington Trail Project at a cost not to exceed \$65,348.00.

Old York Road Historical Society Lease - Alverthorpe Manor
